13 INCOME TAX LAWS AMENDMENT BILL (NO. 3) 1981: Mr Moore (Minister representing the Acting Treasurer) presented a Bill for an Act to amend the law relating to income tax.

Bill read a first time.

Mr Moore moved—That the Bill be now read a second time.

Debate adjourned (Mr Willis), and the resumption of the debate made an order of the day for the next sitting.

14 INCOME TAX (INDIVIDUALS) BILL 1981: Mr Moore (Minister representing the Acting Treasurer) presented a Bill for an Act to impose a tax upon incomes, other than incomes of companies, of corporate unit trusts and of superannuation funds. Bill read a first time.

Mr Moore moved—That the Bill be now read a second time.

Debate adjourned (Mr Willis), and the resumption of the debate made an order of the day for the next sitting.

15 INCOME TAX (COMPANIES, CORPORATE UNIT TRUSTS AND SUPERANNUATION FUNDS) BILL 1981: Mr Moore (Minister representing the Acting Treasurer) presented a Bill for an Act to impose a tax upon incomes of companies, corporate unit trusts and superannuation funds.

Bill read a first time.

Mr Moore moved—That the Bill be now read a second time.

Debate adjourned (Mr Willis), and the resumption of the debate made an order of the day for the next sitting.

16 COMPANIES AND SECURITIES LEGISLATION (MISCELLANEOUS AMENDMENTS)
BILL 1981: The order of the day having been read for the resumption of the debate
on the question—That the Bill be now read a second time—

Debate resumed by Mr J. J. Brown who moved, as an amendment—That all words after "That" be omitted with a view to substituting the following words: "whilst not opposing this Bill, the House—

(1) expresses its concern—

- (a) at the Government's abdication of its responsibility to make national laws for companies and securities pursuant to the Commonwealth's own constitutional powers, and in accordance with the recommendations of the Senate Select Committee on Securities and Exchange in 1974 (the Rae Report);
- (b) at the lack of effective accountability of the National Companies and Securities Commission to either the Government or Parliament of the Commonwealth, or to any other single elected Government or Parliament, and
- (c) that the Parliament of the Commonwealth is not given an opportunity to effectively scrutinise Bills introduced under the Cooperative Companies and Securities Scheme and will not be able effectively to determine company law in the future under this scheme;
- (2) calls upon the Government in the event of the breakdown for any reason of the scheme, of which this Bill is a part, immediately to proceed to the introduction of Commonwealth legislation for the national regulation of companies;
- (3) calls upon the Government to expedite the establishment of an Accounting Standards Review Board, and
- (4) calls upon the Government immediately to pursue a fundamental reform of company law and, as the first stage in such reform, to institute the Companies and Securities Law Revision Committee without delay".

Debate continued.

Amendment negatived.

Question—That the Bill be now read a second time—put and passed—Bill read a second time.

The House resolved itself into a committee of the whole.

In the committee

Clauses 1 to 34, by leave, taken together, and agreed to, after debate. Clauses 35 to 37, by leave, taken together, and agreed to, after debate. Clauses 38 to 50, by leave, taken together, and agreed to, after debate. Remainder of Bill, by leave, taken as a whole, and agreed to, after debate. Bill to be reported without amendment.

The House resumed; Mr Millar reported accordingly.

On the motion of Mr Moore (Minister for Business and Consumer Affairs), the House adopted the report, and, by leave, the Bill was read a third time.

Mr Scholes, by leave, moved the following amendments together:

Page 6, at the end of proposed section 116F add the following sub-section:

"'(2) No warrant shall be issued under sub-section (1) unless the authorized officer is satisfied on reasonable grounds that the person the subject of the warrant became an absentee without leave within the period of 2 years preceding the receipt of the request for assistance.".

Page 7, proposed section 116H, after sub-section (3) insert the following sub-section: "'(3A) An application may be made to the Administrative Appeals Tribunal for a review of a decision by the Minister under paragraph (3) (b) to issue a warrant, and upon the making of an application the operation of the warrant shall be suspended until the application has been heard and determined.".

Debate continued.

Amendments negatived.

Clause agreed to.

Remainder of Bill, by leave, take as a whole-

On the motion of Mr Killen (Minister for Defence), the following amendment was made, after debate:

Clause 13, page 15, omit the clause, substitute the following clause:

Interpretation

"13. Section 5 of the Principal Act is amended—

- (a) by omitting from sub-section (1) the definition of 'Australian service law';
- (b) by omitting 'by arrangement with the Minister' from the definition of 'visiting force' in sub-section (1); and
- (c) by omitting from paragraph (3) (b) ', with the approval of the Minister,'.".

New clause-

On the motion of Mr Killen, the following new clause was inserted in the Bill:

Proof of facts by certificate

"15A. Section 27 of the Principal Act is amended by omitting sub-section (2).". Remainder of Bill, as amended, agreed to. Bill to be reported with amendments.

The House resumed: Mr Millar reported accordingly.

On the motion of Mr Killen, by leave, the House adopted the report, and, by leave, the Bill was read a third time.

19 APPROPRIATION BILL (NO. 1) 1981-82—BUDGET DEBATE: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—And on the amendment moved thereto by Mr Willis, viz.—

That all words after "That" be omitted with a view to substituting the following words: "whilst not opposing the Bill, the House rejects the budget strategy because:

(1) it deliberately reduces the rate of economic growth;

(2) it increases unemployment;

(3) it adds substantially to the rate of inflation;

(4) it relies on a massive private capital inflow;

(5) it fails to tackle the real causes of rising interest rates, and

(6) it increases the burden of taxation to the highest level in our history, and, in addition, deplores the Government's callous disregard of the millions of Australians living in poverty and its continued attempt to reduce the living standards

of the great majority of Australians"-

Debate resumed.

Mr Scott addressing the House-
