7 DISCUSSION OF MATTER OF PUBLIC IMPORTANCE—DEFENCE CAPABILITIES: Mr Speaker informed the House that both Mr Scholes and Mr D. M. Cameron had proposed that definite matters of public importance be submitted to the House for discussion today. In accordance with the provisions of standing order 107, he had given priority to the matter proposed by Mr Scholes, namely, "The destabilising effect on Australia's defence capabilities of conflicting statements and the indecisive defence policies of the Government".

The proposed discussion having received the necessary support—

Mr Scholes addressed the House.

Discussion ensued.

SCHEDULE OF THE REQUESTS BY THE SENATE FOR AMENDMENTS

No. 1—Page 12, clause 25, at end of clause, add the following new sub-clauses:

- "(2) A direction referred to in sub-section (1) has effect, or shall be deemed to have had effect, from and including such date (which, except in the case of a direction that may have the effect of increasing the duty payable in respect of goods, may be a date earlier than the publication in the *Gazette* of the notice containing the direction) as is specified in the notice.
- "(3) The Minister may, by notice published in the *Gazette*, revoke a direction referred to in sub-section (1).
- "(4) A revocation under sub-section (3) has effect from and including such date (which, except in the case of a revocation that may have the effect of increasing the duty payable in respect of goods, may be a date earlier than the publication in the Gazette of the notice containing the revocation) as is specified in the notice.

- "(5) The provisions of sections 48 (other than paragraphs (1) (a) and (b) and sub-section (2)), 49, 49A and 50 of the Acts Interpretation Act 1901 apply in relation to directions given under this section as if—
 - (a) references in those provisions to regulations were references to directions; and
 - (b) references in those provisions to the repeal of a regulation were references to the revocation of a direction.".
- No. 2—Page 13, clause 26, sub-clause (7), lines 33 to 38, leave out the sub-clause, insert the following sub-clause:
- "(7) The provisions of section 48 (other than paragraphs (1) (a) and (b) and sub-section (2)), 49, 49A and 50 of the Acts Interpretation Act 1901 apply in relation to directions given under this section as if—
 - (a) references in those provisions to regulations were references to directions; and
 - (b) references in those provisions to the repeal of a regulation were references to the revocation of a direction.".

On the motion of Mr Hodgman (Minister Assisting the Minister for Industry and Commerce), the requested amendments were made, after debate.

Resolution to be reported.

The House resumed; Mr Drummond reported accordingly. On the motion of Mr Hodgman, the House adopted the report.

Debate resumed by Mr Hawke who moved, as an amendment—That all words after "That" be omitted with a view to substituting the following words: "whilst not generally opposing the provisions of the Bill, the House calls on the Government to extend the principle of disclosure of donations by organizations and to legislate immediately to require full disclosure by companies of all donations of a political nature made by them".

Debate continued.

Amendment negatived.

Question—That the Bill be now read a second time—put and passed—Bill read a second time.

The House resolved itself into a committee of the whole.

Mr Hawke moved the following amendment: Clause 4, page 5, lines 14-18, omit proposed paragraph 132F (1) (b).

Debate continued.

Amendment negatived.

On the motion of Mr Macphee (Minister for Employment and Industrial Relations), the House adopted the report, and, by leave, the Bill was read a third time.
