- 1 The House met, at 10 a.m., pursuant to adjournment. Mr Speaker (the Honourable Dr H. A. Jenkins) took the Chair, and read Prayers.
- 2 **PETITIONS:** The Clerk announced that the following Members had each lodged petitions for presentation, viz.:

  - Mr Drummond and Mr Rocher—from certain citizens praying that there be no requirement for tax to be deducted from payments to owner-drivers of trucks.

- 5 **PUBLIC WORKS COMMITTEE—REFERENCE OF WORK—PERTH AIRPORT, W.A.—INTERNATIONAL TERMINAL COMPLEX AND PARALLEL TAXIWAY:** Mr Hurford (Minister for Housing and Construction), pursuant to notice, moved—That, in accordance with the provisions of the *Public Works Committee Act 1969*, the following proposed work be referred to the Parliamentary Standing Committee on Public Works for consideration and report: Perth Airport international terminal complex and parallel taxiway.
- Mr Hurford presented plans in connection with the proposed work.  
 Question—put and passed.
- 6 **PUBLIC WORKS COMMITTEE—REFERENCE OF WORK—ACCOMMODATION FOR AUSTRALIAN WHEAT BOARD, MELBOURNE, VIC.:** Mr Hurford (Minister for Housing and Construction), pursuant to notice, moved—That, in accordance with the provisions of the *Public Works Committee Act 1969*, the following proposed work be referred to the Parliamentary Standing Committee on Public Works for consideration and report: Australian Wheat Board accommodation at Ceres House, 528 Lonsdale Street, Melbourne, for Head Office and Victorian Branch.
- Mr Hurford presented plans in connection with the proposed work.  
 Question—put and passed.
- 7 **POSTPONEMENT OF ORDERS OF THE DAY:** Ordered—That orders of the day Nos 2 to 4, government business, be postponed until a later hour this day.
- 8 **SUSPENSION OF STANDING AND SESSIONAL ORDERS—GENERAL BUSINESS NOTICE:** Mr Bowen (Leader of the House), by leave, moved—That so much of the standing and sessional orders be suspended as would prevent notice No. 1, general business, given for Thursday, 15 September 1983, by the Leader of the Opposition, being called on forthwith.
- Question—put and passed.
- 9 **LEBANON:** Mr Peacock (Leader of the Opposition), pursuant to notice, moved—That this House—
- (1) notes with grave concern the recent escalation of violence in the Lebanon and in particular abhors the provocative attacks on members of the multi-national peace-keeping force by Syrian-backed militiamen, and
  - (2) urges the phased withdrawal of foreign troops from the Lebanon and the re-establishment of peaceful co-existence amongst the Lebanese people.
- Mr Hayden (Minister for Foreign Affairs) moved, as an amendment—That all the words after “That” be omitted with a view to substituting the following words: “this House—
- (1) notes with grave concern the violence and disorder in Lebanon and deplores the continuing presence of those foreign military forces, including the

Palestinian Liberation Organisation, who are provoking and exacerbating the bloodshed and destruction, and

- (2) considers that an essential step towards the establishment of peaceful co-existence amongst all Lebanese people lies in the cessation of the flow of arms from other countries and the withdrawal of all troops except those necessary to foster the conditions for the development of public order and who are in Lebanon at the genuine invitation of the government”.

Amendment agreed to.

Motion, as amended, agreed to.

Mr MacKellar, by leave, also made a statement with reference to the matter.

Question—put and passed—Bill read a second time.

Question—put and passed—Bill read a second time.
