## TUESDAY, 8 NOVEMBER 1983

- 1 The House met, at 2 p.m., pursuant to adjournment. Mr Speaker (the Honourable Dr H. A. Jenkins) took the Chair, and read Prayers.
- 2 PRIVILEGE: Mr Hodgman, proceeding to give a notice of motion, raised as a matter of privilege the alleged intimidation of Members in connection with the Parliamentary Labor Party's consideration of uranium policy on 7 November 1983. Mr Hodgman produced a copy of an article in The Sydney Morning Herald of 5 November 1983, entitled "PM bullying, minister says"; a Media Summary by the Federal Secretariat of the Liberal Party of Australia, dated 8 November 1983; a Liberal Party of Australia Federal Secretariat transcript of an interview with Mr Dolan, President of the A.C.T.U., on the A.B.C. program "AM" of 8 November 1983, and a National Party of Australia transcript of a 7 November broadcast by the A.B.C. program "PM" of a news conference of the Prime Minister.

Mr Speaker stated that he would consider the matter.

    - (2) is of the opinion that the withdrawal of—
      - (a) the tax rebate on the first \$1000 of dividend income, and
      - (b) the tax concession available to part-time members of the reserve defence forces,

is not in the nation's interests".
