11 MESSAGE FROM THE SENATE—TELEPHONE TAPES AND TRANSCRIPTS—PROPOSED JOINT SELECT COMMITTEE: The following message from the Senate was reported:

Message No. 181

Mr Speaker,

The Senate transmits to the House of Representatives the following Resolution which was agreed to by the Senate this day:

- (1) That a Joint Select Committee be appointed to inquire into and report upon—
 - (a) whether any or all of the tapes and transcripts delivered by *The Age* newspaper to the Attorney-General on 1 February 1984 are authentic and genuine; and
 - (b) whether the conduct of the judge as revealed in the tapes and transcripts referred to in sub-paragraph (a) constituted misbehaviour or incapacity which could amount to sufficient grounds for an address to the Governor-General in Council from both Houses of the Parliament praying for his removal from office pursuant to section 72 (ii) of the Constitution.
- (2) That provisions relating to membership, powers and proceedings of the Committee be contained in a subsequent Resolution.
- (3) That the inquiry commence after the polling day of the New South Wales election.

The Senate requests the concurrence of the House of Representatives in this Resolution.

Mr Lloyd moved—That the clause be omitted, and the following clause be substituted:

- "11. (1) Shares in Aussat are not capable of being held by any person other than—
 - (a) the Commonwealth;
 - (b) a person as trustee for the Commonwealth; or
 - (c) such non-statutory corporation, entity, or person as may be prescribed.
- (2) Each share in Aussat shall be issued with the same rights and restrictions with regard to voting.
- (3) No shares in Aussat can be sold or transferred unless a statement of the proposed sale or transfer has been laid before each House of the Parliament and the proposed sale or transfer has been approved by resolution of each House of the Parliament.
- (4) Any issue, sale or transfer of shares, or any arrangement or agreement, that is contrary to this section is void and of no effect.".

'eligible person' means-

- (a) the Commission;
- (b) the Australian Postal Commission; or
- (c) the Overseas Telecommunications Commission;

'authorised user' means a person provided for in sub-section 16 (2) to the extent (if any) authorised by agreement between Aussat and that authorised user to conduct such a business.".
