On the motion of Mr Hurford (Minister Assisting the Treasurer), by leave, the following amendments were made together:

Clause 15, page 21, lines 43 and 44, and page 22, lines 1-5, omit paragraph (a) of the definition of "relevant service period", substitute the following paragraph:

- "(a) where-
 - (i) the eligible termination payment accrued in whole or in part during a period or periods during which the taxpayer was in employment; and
 - (ii) during the whole or a part of the period, or of any of the periods, referred to in sub-paragraph (i), the taxpayer was a member of a superannuation fund in relation to that employment,

the period, or the aggregate of the periods, of the employment to which the eligible termination payment relates;".

- Clause 60, page 57, lines 38-40, omit sub-clause (12), substitute the following sub-clauses:
 - "(12) The amendments made by sections 9 and 27 apply to eligible termination payments made on or after 1 July 1983.
 - "(12A) The amendment made by section 15, insofar as it relates to eligible termination payments and annuities, applies to eligible termination payments made, and annuities derived, on or after 1 July 1983.
 - "(12B) The amendment made by section 15, insofar as it relates to payments of a supplement to an annuity (not being payments of an annuity), applies to payments made after 30 May 1984.".

Clause 61-

Page 58, line 10, after "annuity and" insert ", subject to sub-section (2) of this section,".

Page 58, at the end of the clause add the following sub-clause:

"(2) Nothing in sub-section (1) affects the application of section 27H of the Principal Act as amended by this Act to a payment of a supplement to an annuity, being a payment that is not a payment of an annuity.".

Bill, as amended, debated and agreed to.

Bill to be reported with amendments.

Debate resumed by Mr Carlton who moved, as an amendment—That all words after "That" be omitted with a view to substituting the following words: "whilst not declining to give the Bill a second reading, the House expresses its concern at the plight of pensioners and beneficiaries whose incomes will be reduced as a consequence of the artificial reduction in the Consumer Price Index caused by the introduction of Medicare".

Debate adjourned (Mr Milton), and the resumption of the debate made an order of the day for the next sitting.

17 ADJOURNMENT: Dr Blewett (Minister for Health) moved—That the House do now adjourn.
