WEDNESDAY, 5 SEPTEMBER 1984

1 The House met, at 10 a.m., pursuant to adjournment. Mr Speaker (the Honourable Dr H. A. Jenkins) took the Chair, and read Prayers.

2 PETITIONS: The Clerk announced that the following Members had each lodged petitions for presentation, viz.:

Mr Adermann, Mr R. F. Edwards, Mr Hollis, Mr Humphreys, Mrs Kelly, Mr Scott and Mr Staples—from certain citizens praying that there be no increases in State aid to private schools and that the primary obligation to government schools be re-affirmed.

Mr Cadman, Dr Klugman, Mr Lusher and Mr Ruddock—from certain citizens praying that the national flag not be changed except by a referendum.

Mr Chynoweth, Mr Fife and Mr Gear—from certain citizens in similar terms to the last preceding petition.

Mr Blunt and Mr Jacobi—from certain citizens praying that recurrent expenditure for technical and further education be increased.

Mr Blunt and Mr Ruddock—from certain citizens praying that the proposed assets test legislation be abandoned and that action be taken to institute a retirement income policy which is fair and equitable.

Mr Cadman and Mr Drummond—from certain citizens praying that regulations amending the Customs (Prohibited Imports) Regulations and Customs (Cinematograph Films) Regulations and the ordinance superseding the ACT Objectionable Publications Ordinance be disallowed and certain other action be taken in relation to censorship matters.

Mr Blunt—from certain citizens in similar terms to the last preceding petition.

Mrs Darling and Mr Moore—from certain residents of Queensland praying that no action be taken to change the national flag.

Mrs Kelly and Mr Macphee—from certain citizens praying that no further action be taken in respect of territorial or local government in the Australian Capital Territory until the findings of the inquiry into ACT finances have been made public and a further referendum of electors has been held.

Mr O'Keefe and Mr Tickner—from certain citizens praying that the Sex Discrimination Bill be amended to prevent inconsistencies with the principles of justice and equality and that a conscience vote on the Bill be permitted to all Members of Parliament.

Mr Blunt—from certain citizens praying that the existing national flag remain sacrosanct.

Mr Braithwaite—from certain citizens praying that moves to change the Australian flag be resisted and any contemplated change be put to the Australian people by referendum.

- Mr Braithwaite—from certain citizens praying that the decision to alter the ACT Classification of Publications Ordinance be abandoned.
- Mr Keogh—from certain citizens in similar terms to the last preceding petition.
- Mr Braithwaite—from certain residents of the district of Pioneer Valley, Qld, praying that the Government reverse its decision in respect of legislation concerning pornographic material.
- Mr Cadman—from certain citizens praying that chiropractic services be included in Medicare when it is introduced.
- Mr Cadman—from certain citizens praying that a suitable alternative site for the proposed airport at Scheyville, NSW, be found.
- Mr E. C. Cameron—from certain elected representatives and officers of local governments praying that funds raised through indexation of the Australian Bicentennial Road Development Program levy be used for road construction work.
- Mrs Darling—from certain citizens praying that a curfew be retained on both runways when the redeveloped Brisbane Airport is commissioned.
- Mrs Darling—from certain citizens praying that amending legislation be drafted in respect of the ACT Classification of Publications Ordinance.
- Mrs Darling—from certain citizens praying that action be taken to avoid discrimination against Queenslanders, in terms of hospital bed charges.
- Mr R. F. Edwards—from certain citizens praying that certain measures be taken to overhaul the Tertiary Education Assistance Scheme.
- Mr Gear—from certain citizens praying that certain action be taken in funding tertiary education.
- Mr Gorman—from certain citizens praying that confectionery be exempt from sales tax.
- Mr Hall—from certain citizens praying that landing rights for foreign warships and aircraft that carry nuclear weaponry be ended and certain action be taken in relation to military bases and peace education.
- Mr Hall—from certain citizens praying that the export of kangaroo products be banned and action be taken to prohibit the commercial killing of kangaroos.
- Mr Hodgman—from certain citizens praying that a parliamentary committee be established to inquire into and report on the effects of pornography.

- Mr Staples—from certain citizens praying that the establishment of nuclear power plants in Australia and the export of Australian uranium be prohibited and a moratorium on all mining and treatment of uranium be declared.

- Mr Tickner—from certain citizens praying that assurances be made that Qantas will not take any action that will lessen the effectiveness of flight attendants in an emergency.

**3 FOREIGN AFFAIRS AND DEFENCE—JOINT COMMITTEE—REPORT ON REGIONAL CONFLICT AND SUPERPOWER RIVALRY IN THE HORN OF AFRICA—GOVERNMENT RESPONSE—MINISTERIAL STATEMENT: Mr Hayden**

(Minister for Foreign Affairs), by leave, made a ministerial statement informing the House of the Government's response to the report of the Joint Committee on Foreign Affairs and Defence on regional conflict and superpower rivalry in the Horn of Africa. Mr MacKellar, by leave, also made a statement in connection with the matter.

**4 SOCIAL SECURITY AND REPATRIATION (BUDGET MEASURES AND ASSETS TEST) BILL**

1984: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—

Debate resumed by Mr Carlton who moved, as an amendment—That all words after “That” be omitted with a view to substituting the following words: “whilst not declining to give the Bill a second reading, the House—

- (1) expresses its concern about the removal of the requirement that widows—being deserted or divorced wives not remarried—must take reasonable steps to pursue maintenance actions before being eligible to receive widows' pensions;
- (2) notes that the removal of this provision from that section of the Act relating to widows' pensions, and its retention in that section relating to supporting parents' benefits, makes the Act inconsistent and discriminatory, and
- (3) expresses its belief that individuals should take responsibility for their own actions and that wherever possible families should be supported by private rather than public means”.

Debate continued.

It being 12.45 p.m., the debate was interrupted in accordance with sessional order 101A, and the resumption of the debate made an order of the day for a later hour this day.

- 27 QANTAS AIRWAYS LIMITED (LOAN GUARANTEE) BILL 1984:** Mr Beazley (Minister for Aviation), pursuant to notice, presented a Bill for an Act relating to the provision of certain equipment for Qantas Airways Limited.

- 29 AUTOMATIC DATA PROCESSING EQUIPMENT BOUNTY AMENDMENT BILL (NO. 2) 1984:** Mr J. J. Brown (Minister Assisting the Minister for Industry and Commerce), pursuant to notice, presented a Bill for an Act to amend section 4 of the *Automatic Data Processing Equipment Bounty Act 1977*.  
Bill read a first time.  
Mr J. J. Brown moved—That the Bill be now read a second time.  
Debate adjourned (Mr Shipton), and the resumption of the debate made an order of the day for the next sitting.

- 30 **BOUNTY (ELECTRIC MOTORS) BILL 1984:** Mr J. J. Brown (Minister Assisting the Minister for Industry and Commerce), pursuant to notice, presented a Bill for an Act to provide for the payment of bounty on the production of certain electric motors.

Bill read a first time.

Mr J. J. Brown moved—That the Bill be now read a second time.

Debate adjourned (Mr Shipton), and the resumption of the debate made an order of the day for the next sitting.

- 31 **CHRISTMAS ISLAND ADMINISTRATION (MISCELLANEOUS AMENDMENTS) BILL 1984:** Mr Uren (Minister for Territories and Local Government), pursuant to notice, presented a Bill for an Act to amend certain laws in connection with reforms of the administration of the Territory of Christmas Island and for other purposes.

Bill read a first time.

Mr Uren moved—That the Bill be now read a second time.

Debate adjourned (Mr Ruddock), and the resumption of the debate made an order of the day for the next sitting.

- 32 **SOCIAL SECURITY AND REPATRIATION (BUDGET MEASURES AND ASSETS TEST) BILL 1984:** The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—*And on the amendment moved thereto by Mr Carlton (see entry No. 4)*—

Debate resumed.

Amendment, by leave, withdrawn.

Question—put and passed—Bill read a second time.
