 - Mr Burr, Mr E. C. Cameron, Mr Fife, Mr Hawker and Mr McArthur—from certain citizens in similar terms to the last preceding petition.
 - Mr Blunt and Mr Rocher—from certain citizens praying that the existing national flag remain sacrosanct.
 - Mr Blunt and Mr Rocher—from certain citizens praying that regulations amending the Customs (Prohibited Imports) Regulations and Customs (Cinematograph Films) Regulations and the ordinance superseding the ACT Objectionable Publications Ordinance be disallowed and certain other action be taken in relation to censorship matters.
 - Mr Lusher—from certain citizens in similar terms to the last preceding petition.
 - Mr Blunt and Mr Scott—from certain citizens praying that there be no increases in State aid to private schools and that the primary obligation to government schools be re-affirmed.
 - Mr Hawker and Mr Rocher—from certain citizens praying that chiropractic services be included in Medicare when it is introduced.
 - Mr Blanchard—from certain citizens praying that certain action be taken to discontinue the mining and supply of uranium.
 - Mr Blunt—from certain citizens praying that recurrent expenditure for technical and further education be increased.
 - Mr D. M. Cameron—from certain citizens praying that the ACT Classification of Publications Ordinance be repealed.
 - Mr D. M. Cameron—from certain citizens praying that the laws which banned the entry and sale of hard-core and violent pornography be re-enacted.
 - Mr E. C. Cameron—from certain elected representatives and officers of local governments praying that funds raised through indexation of the Australian Bicentennial Road Development Program levy be used for road construction work.
 - Mr Carlton—from certain citizens praying that the motor vessel *Krait* remain in the care and maintenance of the Royal Volunteer Coastal Patrol and not be removed to the Australian War Memorial, Canberra.

9 MESSAGE FROM THE SENATE—PROPOSED DISCLOSURE OF EVIDENCE AND **DOCUMENTS OF JOINT COMMITTEES:** The following message from the Senate was reported:

Message No. 265

Mr Speaker.

The Senate transmits to the House of Representatives the following Resolution agreed to by the Senate this day:

(1) That, unless otherwise ordered, the Senate authorises the President to permit any person to examine and copy evidence submitted to, or documents of committees, which are in the custody of the Senate, which have not already been published by the Senate or its committees, and which have been in the Senate's custody for at least ten years:

provided that if such evidence or documents were taken in camera or submitted on a confidential or restricted basis, disclosure shall not take place unless the evidence or documents have been in the custody of the Senate for at least 30 years, and, in the opinion of the President, it is appropriate that such evidence or documents be disclosed:

provided further that the President report to the Senate the nature of any evidence or documents made available under this Resolution and the

person or persons to whom they have been made available.

(2) That the disclosure of evidence or documents of joint committees be authorised by the President of the Senate and the Speaker of the House of Representatives under the same conditions as are provided in paragraph (1).

(3) That the foregoing Resolution have effect notwithstanding anything

contained in the Standing Orders.

The Senate desires the concurrence of the House of Representatives in that part of the Resolution relating to the evidence and documents of joint committees.
