- 28A. (a) A Committee of Members' Interests shall be appointed at the commencement of each Parliament—
 - (i) to inquire into and report upon the arrangements made for the compilation, maintenance and accessibility of a Register of Members' Interests;
 - (ii) to consider any proposals made by Members and others as to the form and content of the register;
 - (iii) to consider any specific complaints made in relation to the registering or declaring of interests;
 - (iv) to consider what changes to any code of conduct adopted by the House are necessary or desirable;
 - (v) to consider what classes of person (if any) other than Members ought to be required to register and declare their interests, and
 - (vi) to make recommendations upon these and any other matters which are relevant.
- (b) The committee shall consist of 7 members, 4 Members to be nominated by either the Prime Minister, the Leader of the House or the Government Whip and 3 Members to be nominated by either the Leader of the Opposition, the Deputy Leader of the Opposition or the Opposition Whip:

Provided that, where the Opposition is composed of 2 parties, the committee shall consist of 4 Members to be nominated by either the Prime Minister, the Leader of the House or the Government Whip, 2 Members to be nominated by either the Leader of the Opposition, the Deputy Leader of the Opposition or the Opposition Whip, and 1 Member to be nominated by either the Leader of the Third Party, the Deputy Leader of the Third Party or the Third Party Whip.

- (c) The committee shall elect as chairman of the committee one of the Members nominated either by the Prime Minister, the Leader of the House or the Government Whip.
- (d) The committee shall have power to send for persons, papers and records but shall not exercise that power, nor undertake an investigation of the private interests of any person, unless approved by not less than 4 members of the committee other than the chairman.
- (e) The committee shall have power to confer with a similar committee of the Senate.
- (f) The committee shall, as soon as practicable after 31 December in each year, prepare and table in the House a report on its operations during that year and shall also have power to report from time to time.

28 DECLARATION AND REGISTRATION OF MEMBERS' INTERESTS: Mr Bowen (Minister for Trade), having amended, by leave, notice No. 2, government business, moved—That the following resolutions relating to the registration and declaration of Members' interests be adopted, such resolutions to have effect from the commencement of the 34th Parliament and to continue in force unless and until amended or repealed by the House of Representatives in this or a subsequent Parliament:

(1) Declaration of Members' interests

That within 28 days of making and subscribing an oath or affirmation as a Member of the House of Representatives and within 28 days after the commencement of the first period of sittings in each subsequent calendar year while remaining a Member of the House of Representatives, each Member shall provide to the Registrar of Members' Interests, a statement of—

- (1) the Member's registrable interests, and
- (2) the registrable interests of which the Member is aware (a) of the Member's spouse and (b) of any children who are wholly or mainly dependent on the Member for support,

in accordance with resolutions adopted by the House and in a form determined by the Committee of Members' Interests from time to time, and shall also notify any alteration of those interests to the Registrar within 28 days of that alteration occurring.

(2) Registrable interests

That the statement of a Member's registrable interests to be provided by a Member shall include the registrable interests of which the Member is aware (1) of the Member's spouse and (2) of any children who are wholly or mainly dependent on the Member for support, and shall cover the following matters:

- (a) shareholdings in public and private companies (including holding companies) indicating the name of the company or companies;
- (b) family and business trusts and nominee companies—
 - (i) in which a beneficial interest is held, indicating the name of the trust, the nature of its operation and beneficial interest, and
 - (ii) in which the Member, the Member's spouse, or a child who is wholly or mainly dependent on the Member for support, is a trustee, indicating the name of the trust, the nature of its operation and the beneficiary of the trust;
- (c) real estate, including the location (suburb or area only) and the purpose for which it is owned;
- (d) interests in companies to be determined by the Committee of Members' Interests;
- (e) partnerships, indicating the nature of the interests, the activities of the partnership and the total amounts of its assets and liabilities;
- (f) liabilities (excluding short-term credit arrangements) indicating the nature of the liability and the creditor concerned;
- (g) the nature of any bonds, debentures and like investments;
- (h) saving or investment accounts, indicating their nature and the name of the bank or other institutions concerned;
- (i) the nature of any other assets (including collections, but excluding household and personal effects) each valued at over \$5000;
- (i) the nature of any other substantial sources of income;
- (k) gifts valued at more than \$250 received from official sources, or at more than \$100 where received from other than official sources;
- (1) any sponsored travel or hospitality received, and
- (m) any other interests, such as membership of organisations, where a conflict of interest with a Member's public duties could foreseeably arise or be seen to arise.

(3) Register and Registrar of Members' Interests

That-

- (a) at the commencement of each Parliament, and at other times as necessary, Mr Speaker shall appoint an officer of the Department of the House of Representatives as the Registrar of Members' Interests and that officer shall also be clerk to the Committee of Members' Interests:
- (b) the Registrar of Members' Interests shall, in accordance with procedures determined by the Committee of Members' Interests, maintain a Register of Members' Interests in a form to be determined by that committee from time to time;
- (c) as soon as possible after the commencement of each Parliament and in each subsequent calendar year during the life of that Parliament, the chairman of the Committee of Members' Interests shall table in the House a copy of the completed Register of Members' Interests and shall also table from time to time as required any notification by a Member of alteration of those interests, and
- (d) the Register of Members' Interests shall be available for inspection by any person under conditions to be laid down by the Committee of Members' Interests from time to time.

(4) Declaration of interest in debate and other proceedings

That, notwithstanding the lodgement by a Member of a statement of the Member's registrable interests and the registrable interests of which the Member is aware (1) of the Member's spouse and (2) of any children who are wholly or mainly dependent on the Member for support, and the incorporation of that statement in a Register of Members' Interests, a Member shall declare any relevant interest—

- (a) at the beginning of his or her speech if the Member should participate in debate in the House, committee of the whole House, or a committee of the House (or of the House and the Senate), and
- (b) as soon as practicable after a division is called for in the House, committee of the whole House, or a committee of the House (or of the House and the Senate) if the Member proposes to vote in that division, and

the declaration shall be recorded and indexed in the *Votes and Proceedings* or minutes of proceedings (as applicable) and in any *Hansard* report of those proceedings or that division:

Provided that it shall not be necessary for a Member to declare an interest when directing a question seeking information in accordance with standing order 142 or 143.

- 29 VIDEO CLASSIFICATION—PROPOSED JOINT SELECT COMMITTEE: The order of the day having been read for the resumption of the debate on the motion of Mr Young (Leader of the House)—
 - (1) That a joint select committee be appointed to report on the operation of Regulation 4A of the Customs (Prohibited Imports) Regulations and the ACT Classification of Publications Ordinance 1983 in relation to videotapes and videodiscs and in particular—
 - (a) the effectiveness of such legislation by comparison with previous legislation purporting to govern the importation, production, reproduction, sale and hire of violent, pornographic or otherwise obscene material;
 - (b) whether the present classification system, as applied by the Film Censorship Board, is adequate as a basis for import and point of sale controls;
 - (c) whether video retailers are observing the conditions of sale or hire attached to 'X' classified material, particularly in relation to children under 18 years;
 - (d) whether Regulation 4A of the Customs (Prohibited Imports) Regulations is adequate in identifying categories of prohibited material, and operating effectively in preventing the importation of videotapes/discs falling within the prohibited categories;
 - (e) whether children under the age of 18 years are gaining access to videotapes/discs containing violent, pornographic or otherwise obscene material:
 - (f) whether the ACT Classification of Publications Ordinance 1983 should be amended to make it an offence for persons purchasing or hiring 'X' classified videotapes/discs to allow, suffer or negligently permit children to view such material;
 - (g) whether cinemas should be permitted to screen for public exhibition 'X' classified material, subject to prohibition from entry of persons under the age of 18 years;
 - (h) whether films which would merit an 'X' classification are being produced in Australia and if so whether Australian men and women are adequately protected by existing law from pressure to act in such films, and
 - (i) the likely effects upon people, especially children, of exposure to violent, pornographic or otherwise obscene material.
 - (2) That the committee consist of 7 members, 3 Members of the House of Representatives to be nominated by either the Prime Minister, the Leader of the House or the Government Whip, 1 Member of the House of Representatives to be nominated by either the Leader of the Opposition, the Deputy Leader of the Opposition or the Opposition Whip, 1 Member of the House of Representatives to be nominated by either the Leader of the National Party, the Deputy Leader of the National Party or the National Party Whip, 1 Senator to be nominated by the Leader of the Government in the Senate and 1 Senator to be nominated by any minority group or groups or independent Senator or independent Senators.
 - (3) That every nomination of a member of the committee be forthwith notified in writing to the President of the Senate and the Speaker of the House of Representatives.
 - (4) That the committee proceed to the dispatch of business not withstanding that all members have not been duly nominated and appointed and notwithstanding any vacancy.
 - (5) That the committee elect a Government Member as its chairman.
 - (6) That the chairman of the committee may, from time to time, appoint another member of the committee to be the deputy chairman of the committee, and that the member so appointed act as chairman of the committee at any time when there is no chairman or the chairman is not present at a meeting of the committee.
 - (7) That, in the event of an equality of voting, the chairman, or the deputy chairman when acting as chairman, have a casting vote.

- (8) That the quorum of the committee be 3 members.
- (9) That the committee be provided with all necessary staff, facilities and resources.
- (10) That the committee have power to send for and examine persons, papers and records, to move from place to place, to sit in public or in private, notwithstanding any prorogation of the Parliament, and have leave to report from time to time its proceedings and the evidence taken and such interim recommendations it may deem fit.
- (11) That the committee be empowered to print from day to day such papers and evidence as may be ordered by it, and a daily *Hansard* be published of such proceedings as take place in public.
- (12) That the foregoing provisions of this resolution, so far as they are inconsistent with the standing orders, have effect notwithstanding anything contained in the standing orders.
- (13) That a message be sent to the Senate acquainting it of this resolution and requesting that it concur and take action accordingly.
- Motion amended by Mr Bowen (Minister for Trade), by leave, by omitting all words after "That" (first occurring) and substituting the following words: "a joint select committee be appointed to inquire into and report upon the operation of Regulation 4A of the Customs (Prohibited Imports) Regulations and the ACT Classification of Publications Ordinance 1983 in relation to videotapes and videodiscs and in particular—
 - (a) the effectiveness of such legislation by comparison with previous legislation purporting to govern the importation, production, reproduction, sale and hire of violent, pornographic or otherwise obscene material;

 - (g) whether cinemas should be permitted to screen for public exhibition material classified above 'R', subject to prohibition from entry of persons under the age of 18 years;
 - (h) whether films which would merit a classification above 'R' are being produced in Australia and if so whether Australian men and women are adequately protected by existing law from pressure to act in such films, and
 - (i) the likely effects upon people, especially children, of exposure to violent, pornographic or otherwise obscene material.
 - (2) That the committee consist of 9 members, 3 Members of the House of Representatives to be nominated by either the Prime Minister, the Leader of the House or the Government Whip, 1 Member of the House of Representatives to be nominated by either the Leader of the Opposition, the Deputy Leader of the Opposition or the Opposition Whip, 1 Member of the House of Representatives to be nominated by either the Leader of the National Party, the Deputy Leader of the National Party or the National Party Whip, 2 Senators to be nominated by the Leader of the Government in the Senate, 1 Senator to be nominated by the Leader of the Opposition in the Senate and 1 Senator to be nominated by any minority group or groups or independent Senator or independent Senators.

- (3) That every nomination of a member of the committee be forthwith notified in writing to the President of the Senate and the Speaker of the House of Representatives.
- (4) That the committee elect a Government Member as its chairman.
- (5) That the committee elect a deputy chairman who shall perform the duties of the chairman of the committee at any time when the chairman is not present at a meeting of the committee, and at any time when the chairman and deputy chairman are not present at a meeting of the committee, the members present shall elect another member to perform the duties of the chairman at that meeting.
- (6) That 3 members of the committee constitute a quorum of the committee.
- (7) That the committee have power to send for persons, papers and records, and to move from place to place.
- (8) That the committee report by 30 April 1985.
- (9) That the foregoing provisions of this resolution, so far as they are inconsistent with the standing orders, have effect notwithstanding anything contained in the standing orders.
- (10) That a message be sent to the Senate acquainting it of this resolution and requesting that it concur and take action accordingly".

Ordered—That Mr Spender be granted an extension of time.

Mr Spender, by leave, moved the following amendments together:

Omit sub-paragraph (1) (a), substitute the following sub-paragraph:

"(a) the effectiveness of such legislation to control adequately the importation, production, reproduction, sale and hire of violent, pornographic or otherwise obscene material;".

Sub-paragraph (1) (c), omit "'X'".

After sub-paragraph (1) (d) insert the following sub-paragraph:

"(dd) The extent to which videotapes/discs containing pornographic and violent material are available to the community;".
