## TUESDAY, 19 MARCH 1985

- 1 The House met, at 2 p.m., pursuant to adjournment. Mr Speaker (the Honourable Dr H. A. Jenkins) took the Chair, and read Prayers.
- 2 MINISTERIAL ARRANGEMENTS: Mr Hawke (Prime Minister) informed the House that Senator Button (Minister for Industry, Technology and Commerce) would be represented in this House by Mr Jones (Minister for Science).
  - Mr Hawke also informed the House that, during the absence abroad of Mr Dawkins (Minister for Trade), Mr Kerin (Minister for Primary Industry) was acting as Minister for Trade and Mr Hurford (Minister for Immigration and Ethnic Affairs) was representing the Minister for Education in this House.
  - Mr Hawke further informed the House that, during his forthcoming absence abroad, Mr Bowen (Deputy Prime Minister) would act as Prime Minister.
- 3 SUSPENSION OF STANDING ORDERS—MOTION OF CENSURE OF THE GOVERNMENT: Mr Peacock (Leader of the Opposition) having delivered to the Clerk a notice of motion of censure of the Government which he proposed to move at the next sitting and the notice having been reported to the House—
  - Mr Young (Leader of the House), by leave, moved—That so much of the standing orders be suspended as would prevent the Leader of the Opposition moving forthwith the motion of censure of the Government of which he has given notice for the next sitting. Ouestion—put and passed.

Mr Young informed the House that he accepted the notice of motion as a motion of censure of the Government for the purposes of standing order 110.

- 4 MOTION OF CENSURE OF THE GOVERNMENT: Mr Peacock (Leader of the Opposition)
  - moved—That this House censures the Government in that since the last sitting of the House the Government has inflicted upon Australia a further series of unprecedented national security debacles that have resulted in—
    - (1) the grave weakening of the ANZUS Alliance as an operative force in the region and a contributor to the Western Alliance;
    - (2) the alienation of the ASEAN nations;
    - (3) the weakening of Australia's contribution to international peace and disarmament;
    - (4) the replacement of Australia's once solid international standing by a reputation for unreliability, inconsistency and naivety, and
    - (5) the subordination of the national interest to the demands of the Labor Party's factions.

Debate ensued.

Ordered—That Mr Hayden (Minister for Foreign Affairs) be granted an extension of time.

Suspension of standing orders—Further extension of time for speech: Mr Young (Leader of the House) moved—That so much of the standing orders be suspended as would prevent Mr Hayden completing his speech.

Question-put and passed, with the concurrence of an absolute majority.

Suspension of standing orders—Extended time for speech: Mr Young, by leave, moved—That so much of the standing orders be suspended as would prevent Mr Macphee speaking without limitation of time.

Question-put and passed.

Debate continued.

Question-That the motion be agreed to-put.

MAY IT PLEASE YOUR EXCELLENCY:

We, the House of Representatives of the Commonwealth of Australia, in Parliament assembled, desire to express our loyalty to our Most Gracious Sovereign, and to thank Your Excellency for the Speech which you have been pleased to address to Parliament—

#### 22 MESSAGE FROM THE SENATE-VIDEO MATERIAL-JOINT SELECT COMMITTEE: The following message from the Senate was reported:

Mr Speaker,

Message No. 12

The Senate, having considered Message No. 6 of the House of Representatives, has agreed to the following Resolution in connection therewith, viz.:

- (1) That the Senate concurs in the Resolution transmitted to the Senate by Message No. 6 of the House of Representatives relating to the appointment of a Joint Select Committee on Video Material, subject to the following modifications---
  - (a) paragraph (1), after "joint select committee", insert ", to be known as the Joint Select Committee on Video Material,";
  - (b) paragraph (1), after "operation of", insert "the Customs (Cinematograph Films) Regulations,";
  - (c) sub-paragraph 1 (a), leave out "by comparison with previous legislation purporting to govern", insert "to adequately control";
  - (d) sub-paragraph 1 (c), leave out "'X'";
  - (e) after sub-paragraph 1 (c), insert the following new sub-paragraph:
    - "(ca) whether 'R' rated videos should be permitted to be displayed for sale or hire in the same area and side by side with 'G', 'PG' and 'M' rated videos and, if not, what restrictions should be imposed on the display of 'R' rated material;";
  - (f) after sub-paragraph 1 (d), insert the following new sub-paragraph:
    - "(da) examine the extent to which videotapes/discs containing pornographic and violent material are available to the community in general;";
  - (g) after sub-paragraph 1 (f), insert the following new sub-paragraph:
    - "(fa) whether the sale, hire, distribution or exhibition of films and videotapes/discs that would, under existing laws, be accorded a classification above 'R' should be made unlawful;";
  - (h) paragraph (2), leave out the paragraph, insert the following paragraph:

"(2) That the Committee consist of 9 members, 3 Members of the House of Representatives to be nominated by either the Prime Minister, the Leader of the House or the Government Whip, 1 Member of the House of Representatives to be nominated by either the Leader of the Opposition, the Deputy Leader of the Opposition or the Opposition Whip, 1 Member of the House of Representatives to be nominated by either the Leader of the National Party, the Deputy Leader of the National Party or the National Party Whip, 2 Senators to be nominated by the Leader of the Government in the Senate, 1 Senator to be nominated by the Leader of the Opposition in the Senate and 1 Senator to be nominated by any minority group or groups or any independent Senator or independent Senators.".

(2) That the provisions of the Resolution, so far as they are inconsistent with the Standing Orders, have effect notwithstanding anything contained in the Standing Orders.

The Senate requests the concurrence of the House of Representatives in the Senate's modifications of the Resolution transmitted to the Senate by the House.
