- 1 The House met, at 2 p.m., pursuant to adjournment.
- 2 ABSENCE OF MR SPEAKER: The Clerk having informed the House that Mr Speaker (the Honourable Dr H. A. Jenkins) was unavoidably absent, the Chairman of Committees (Mrs Child) took the Chair as Acting Speaker, and read Prayers.
- 3 DEATH OF FORMER MEMBER (THE HONOURABLE SIR PERCY SPENDER): Mr Hawke (Prime Minister) referred to the death of the Honourable Sir Percy Spender, and moved—That this House expresses its deep regret at the death of the Honourable Sir Percy Claude Spender, KCVO, KBE, QC, a former Minister and Member for the Division of Warringah, who died on 3 May 1985, places on record its appreciation of his long and meritorious public service and tenders its profound sympathy to his wife and family.
 - And Mr Peacock (Leader of the Opposition) having seconded the motion, and Mr Sinclair (Leader of the National Party of Australia) and other Members having addressed the House in support thereof, and all Members present having risen, in silence—

Question-passed.

4 DEATH OF FORMER MEMBER (THE HONOURABLE R. W. HOLT): The Acting Speaker informed the House of the death, on 1 May 1985, of the Honourable Robert Wilfred Holt, a Member of this House for the Division of Darebin from 1955 to 1958.

As a mark of respect to the memory of the deceased all Members present stood, in silence.

- 5 DEATH OF SPEAKER OF THE HOUSE OF REPRESENTATIVES OF NEW ZEALAND (SIR BASIL ARTHUR): The Acting Speaker informed the House of the death, on 1 May 1985, of Sir Basil Arthur, Speaker of the House of Representatives of New Zealand, and that Mr Speaker had sent a message of sympathy to Lady Arthur.

(b) Mr Speaker interrupting the debate at 11 p.m., and (c) a Minister requiring that the debate be extended until 11.10 p.m., on each Wednesday, for the remainder of this period of sittings.
