# WEDNESDAY, 8 MAY 1985

1 The House met, at 10 a.m., pursuant to adjournment. The Acting Speaker (Mrs Child) took the Chair, and read Prayers.

2 EXPORT INSPECTION CHARGE BILL 1985: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—

Debate resumed by Mr Hunt (Deputy Leader of the National Party of Australia) who moved, as an amendment—That all words after "That" be omitted with a view to substituting the following words: "whilst not declining to give the Bill a second reading, the House is of the opinion that excessive increases in export inspection charges over the past 2 years have seriously damaged the export competitiveness of Australian agricultural industries in a period of intense world competition against other nations which do not impose these export cost burdens".

Debate continued.

Mr Hawker rising to address the House-

Closure: Mr Humphreys moved—That the question be now put.

Question—That the question be now put—put and passed.

And the question—That the words proposed to be omitted stand part of the question—was put accordingly, and passed.

Debate on the motion—That the Bill be now read a second time—continued.

Question—put and passed—Bill read a second time.

Leave granted for third reading to be moved forthwith.

On the motion of Mr Kerin (Minister for Primary Industry), the Bill was read a third time.

3 EXPORT INSPECTION CHARGE COLLECTION BILL 1985: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—

Question—put and passed—Bill read a second time.

Leave granted for third reading to be moved forthwith.

On the motion of Mr Kerin (Minister for Primary Industry), the Bill was read a third time.

4 EXPORT INSPECTION LEGISLATION (CONSEQUENTIAL AMENDMENTS) BILL 1985:
The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—

Question—put and passed—Bill read a second time.

Leave granted for third reading to be moved forthwith.

On the motion of Mr Kerin (Minister for Primary Industry), the Bill was read a third time.

5 FISHING LEGISLATION AMENDMENT BILL 1985: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—

Debate resumed.

Question—put and passed—Bill read a second time.

The House resolved itself into a committee of the whole.

Mr Hunt (Deputy Leader of the National Party of Australia) moved the following amendment: Clause 28, page 16, omit the clause, substitute the following clause:

Reconsideration and review of decisions by the Minister or Secretary

"28. Section 16A of the Principal Act is amended by omitting from sub-section (1) '9A (1)' (wherever occurring) and substituting '9A (1), 3A'.".

Debate continued.

Amendment negatived.

Bill agreed to.

Bill to be reported without amendment.

The House resumed; Mr Mountford reported accordingly.

15 PRIVILEGE—COMPLAINT OF BREACH: Mr Sinclair (Leader of the National Party of Australia) raised, as a matter of privilege, notice at the Parliament House Post Office of a union ban on all mail despatches to Queensland until 13 May 1985, and referred to the effect of the ban on Members' mail to constituents.

The Acting Speaker stated that she would consider the matter and advise the House of her decision in due course.

16 DISCUSSION OF MATTER OF PUBLIC IMPORTANCE—ASSETS TEST: The Acting Speaker informed the House that Mr Peacock (Leader of the Opposition) had proposed that a definite matter of public importance be submitted to the House for discussion, namely, "The continuing unjust imposition on Australian families of the Government's punitive assets test".

The proposed discussion having received the necessary support—

Mr Peacock addressed the House.

33 PRIVILEGE—STATEMENT BY ACTING SPEAKER: The Acting Speaker referred to the matter raised earlier this day by Mr Sinclair (Leader of the National Party of Australia) (see entry No. 15) and stated that as she understood it, the bans affected all mail to Queensland and that Members were not being subjected to particular action in their capacity as Members. She referred to the general principle that the House should exercise its penal jurisdiction only when satisfied that to do so would be essential in order to provide reasonable protection for the House, its Members and committees from substantial interference with their functions.

The Acting Speaker stated that, in her opinion, the matter did not constitute a *prima* facie case of breach of privilege as would enable it to take precedence over other business.
