- (6) Notwithstanding any other provision of this Act, but subject otherwise to the rules as to admissibility of evidence, documents or information falling within sub-section (1) may be admitted in evidence in proceedings for the prosecution of an offence against a law of the Commonwealth, or of a State, or of a Territory.’”.
