## **TUESDAY, 10 SEPTEMBER 1985**

- 1 The House met, at 2 p.m., pursuant to adjournment. Mr Speaker (the Honourable Dr H. A. Jenkins) took the Chair, and read Prayers.
- 2 LEADERSHIP AND WHIPS OF THE LIBERAL PARTY OF AUSTRALIA: Mr Howard, as Leader of the Opposition, informed the House that the Parliamentary Liberal Party had elected him as its Leader and Mr N. A. Brown as its Deputy Leader. Mr E. C. Cameron and Mr Andrew had been appointed Opposition Whip and Deputy Opposition Whip, respectively.
  - Mr Howard, by leave, made a statement concerning the attitude and role of the Opposition.
  - Mr Hawke (Prime Minister), by leave, made a statement congratulating Mr Howard and relating to the role of the Opposition.
- 3 GOVERNMENT WHIPS: Mr Hawke (Prime Minister) informed the House that, during the absence of Mr Humphreys (Government Whip) owing to public business overseas, Mr Cunningham would act as Government Whip and Mr Scott as Deputy Whip.
- 4 DEATH OF SIR MACFARLANE BURNET: Mr Hawke (Prime Minister) referred to the death of Sir Macfarlane Burnet, and moved—That this House expresses its deep regret at the death on 31 August 1985 of Sir Macfarlane Burnet, OM, AK, KBE, places on record its recognition and esteem for his meritorious public service and unique contribution to medical science, and tenders its profound sympathy to Sir Macfarlane's widow and family.
  - And Mr Howard (Leader of the Opposition) having seconded the motion, and Mr Sinclair (Leader of the National Party of Australia) and other Members having addressed the House in support thereof, and all Members present having risen, in silence—

Brown (Deputy Leader of the Opposition) had proposed that a definite matter of public importance be submitted to the House for discussion, namely, "The damage to employment prospects arising from the new prices and incomes accord between the Government and the ACTU".

- 18 APPROPRIATION BILL (NO. 1) 1985-86—BUDGET DEBATE: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—And on the amendment moved thereto by Mr Peacock, viz.—That all words after "That" be omitted with a view to substituting the following words: "the House condemns the Budget because—
  - (1) it is only half a Budget which fails to outline any approach to the urgent problems of tax reform and tax relief;
  - (2) it fails to remove the threat of new taxes on investment and jobs, such as a capital gains tax which will include death duties and gift taxes;
  - (3) it condemns 750 000 Australians to higher marginal tax brackets during the year;
  - (4) it fails to address the fundamental problems facing the Australian economy, particularly high inflation, the lack of international competitiveness and the need for further cuts in Government spending;
  - (5) if fails to provide clear direction on the Government's approach to discounting wage indexation for the effects of depreciation of the dollar and so potentially destroys its employment benefits;
  - (6) it fails to move towards the deregulation of labour markets required to give all Australians the chance for a job, and
  - (7) it burdens Australia with the threat of continued high interest rates which hurt not only homebuyers but hit business investment and jobs"
