I have not been made aware of any in the past. The only accusations, imputations or rumours that I have detected at any stage are in that rather grubby little article in *The Daily Telegraph* this morning.";
 - (2) failure to act on audit reports dated 16 August and 7 November 1985, the latter drawing attention to weaknesses in the areas of travel and subsistence, cash handling procedures and the payments system;

- (3) failure to exercise proper ministerial control of expenditure of taxpayers' money by officers of the Australian Institute of Sport;
- (4) failure to conduct a proper public inquiry into all aspects of the financial administration of the Australian Institute of Sport, and
- (5) failure to respond adequately to the conclusion contained in the auditor's report that said "Internal audit work carried out both prior to and during the current exercise causes us to be concerned as to the financial management and financial well-being generally of the Institute.".
