2 SPEAKER—RESIGNATION—ACCEPTANCE BY GOVERNOR-GENERAL: The following communication from His Excellency the Governor-General was received, and was read at the Table by the Clerk:

I desire to inform the House of Representatives that I have received a letter dated 20 December 1985 from the Honourable Dr Henry Alfred Jenkins, MP, tendering his resignation as Speaker of the House of Representatives, and that I have accepted his resignation.

Accordingly, I invite the House to elect a new Speaker.

3 ELECTION OF SPEAKER: Mr Charles, addressing himself to the Clerk, proposed to the House for its Speaker Mrs Child, and moved—That she do take the Chair of this House as Speaker, which motion was seconded by Mrs Kelly.

Mrs Child informed the House that she accepted nomination.

Mr N. A. Brown (Deputy Leader of the Opposition), addressing himself to the Clerk, proposed to the House for its Speaker Mr Rocher, and moved—That he do take the Chair of this House as Speaker, which motion was seconded by Mr Sinclair (Leader of the National Party of Australia).

Mr Rocher informed the House that he accepted nomination.

There being no further proposal-

Debate ensued.

The House proceeded to ballot; and the ballot being concluded, the Clerk reported the result, as follows:

Mrs Child was thereupon declared elected as Speaker, and Mr Charles and Mrs Kelly conducted her to the Chair.

Mrs Child returned her acknowledgments to the House for the honour it had been pleased to confer upon her by choosing her to be its Speaker, and thereupon sat down in the Chair.

Then the Mace, which before lay under the Table, was laid upon the Table.

Mr Hawke (Prime Minister), Mr Howard (Leader of the Opposition), Mr Sinclair, Mr Rocher, Mr Charles and Mr Scholes (Minister for Territories) congratulated Madam Speaker, who expressed her thanks.

4 PRESENTATION OF THE SPEAKER: Mr Hawke (Prime Minister) stated that he had ascertained that it would be His Excellency the Governor-General's pleasure to receive the Speaker in the Library of the Parliament in a few moments.

Madam Speaker, thereupon, went with the Members of the House to attend His Excellency; and, having returned, Madam Speaker reported that the House had proceeded to the Library of the Parliament, and that she had presented herself to His Excellency the Governor-General as the choice of the House of Representatives, and that His Excellency had been kind enough to congratulate

 - I, SIR NINIAN MARTIN STEPHEN, Governor-General of the Commonwealth of Australia, pursuant to section 42 of the Constitution of the Commonwealth of Australia, hereby authorise JOAN CHILD, Speaker of the House of Representatives, from time to time, at Parliament House, Canberra, in the Australian Capital Territory, to administer the oath or affirmation of allegiance to such Members of the House of Representatives as have not already made and subscribed that oath or affirmation since their election or last election to the House of Representatives.
