- 1 The House met, at 10 a.m., pursuant to adjournment. Madam Speaker (the Honourable Joan Child) took the Chair, and read Prayers.
  - 2 **BROADCASTING OF EXCERPTS OF PROCEEDINGS—STATEMENT BY MADAM SPEAKER:** Madam Speaker informed the House of the decision by the Joint Committee on the Broadcasting of Parliamentary Proceedings to insert an additional condition in the guidelines governing access to proceedings of the House for the purpose of recording and broadcasting excerpts.  
Mr Sinclair (Leader of the National Party of Australia) addressed himself to the matter.
  - 3 **AUSTRALIAN CAPITAL TERRITORY COUNCIL BILL 1986:** Mr Scholes (Minister for Territories), pursuant to notice, presented a Bill for an Act to establish a council to govern the Australian Capital Territory with respect to certain matters and to make laws with respect to those matters, and for related purposes.  
Bill read a first time.  
Mr Scholes moved—That the Bill be now read a second time.  
*Papers:* Mr Scholes, by leave, presented the following paper:  
Australian Capital Territory Council Bill—Planning, development, lease marketing and lease management—Relationships between the Commonwealth and the ACT Council—Statement.  
Mr Scholes also presented an explanatory memorandum to the Bill.  
Debate adjourned (Mr Carlton), and the resumption of the debate made an order of the day for the next sitting.
  - 4 **AUSTRALIAN CAPITAL TERRITORY COUNCIL (CONSEQUENTIAL PROVISIONS) BILL 1986:** Mr Scholes (Minister for Territories), pursuant to notice, presented a Bill for an Act to enact certain transitional provisions, and to amend certain Acts, in consequence of the enactment of the *Australian Capital Territory Council Act 1986*.  
Bill read a first time.  
Mr Scholes moved—That the Bill be now read a second time.  
*Paper:* Mr Scholes presented an explanatory memorandum to the Bill.  
Debate adjourned (Mr Lloyd), and the resumption of the debate made an order of the day for the next sitting.

Mr Hunt and Mr Nehl—from certain electors of the Division of Cowper praying that the Australian Bill of Rights Bill and associated bills be rejected, the Human Rights and Equal Opportunity Commission be abolished and ratification of the Covenant on Civil and Political Rights be withdrawn.

Mr Braithwaite—from certain electors of the Division of Dawson praying that the Australian Bill of Rights Bill not be passed.

- Mr Braithwaite—from certain residents of the Division of Dawson praying that the capital gains tax proposal be abandoned.
- Mr Cleeland—from certain citizens praying that the spouse rebate be retained and certain other action be taken to assist women who choose to remain at home.
- Mr Cleeland—from certain citizens praying that 1989 be proposed as the International Year for Repairing the Earth and certain other action be taken in support of world peace.
- Mr Cleeland—from certain citizens praying that sales tax be replaced by a broad based consumption tax with a uniform ad valorem rate.
- Mr Cleeland—from certain residents of Victoria praying that there be no changes to current funding arrangements of the children's services program until a full review takes place.
