3 PAPER: Mr Howe (Minister for Social Security) presented the following paper:

Corrigendum to explanatory memorandum to the Social Security and Veterans' Affairs (Miscellaneous Amendments) Bill 1986.

4 SOCIAL SECURITY AND VETERANS' AFFAIRS (MISCELLANEOUS AMENDMENTS)
BILL 1986: The order of the day having been read for the resumption of the
debate on the question—That the Bill be now read a second time—

Debate resumed by Mr Blunt who moved, as an amendment—That all words after "That" be omitted with a view to substituting the following words: "the House—

- (1) condemns the Government for-
  - (a) its action in deferring all automatic pension increases due on 1 November 1986;
  - (b) its uncaring further 8 month deferral of the poverty traps relief measures;
  - (c) its illogical means testing of family allowances for 16 and 17 year olds, and
  - (d) its lifting of the rent threshold before a person paying private rent can qualify for rent assistance;
- (2) condemns the Government for persisting with its inequitable assets test on pensioners;
- (3) lodges a strong protest over the Government's continued assault on veterans and war widows through further restricting access to the Repatriation Pharmaceutical Benefits Scheme and freezing the maximum level of social security component where a war widow is also eligible for an aged pension;
- (4) calls on the Government to ensure a voluntary clearance is obtained from the veteran before proceeding with a claim on the veteran's private health insurance and points out that this aspect of the Bill seeking recompense for veterans' hospital and medical costs constitutes a breach of the fundamental obligation to look after those who served this country in the time of war, and
- (5) condemns the Government for taking three and a half years to do anything about social security fraud and doing nothing new or positive but relying merely on window dressing and public relations".
