- 1 The House met, at 9 a.m., pursuant to adjournment. Madam Speaker (the Honourable Joan Child) took the Chair, and read Prayers.
  - 2 **NURSING HOMES AND HOSTELS LEGISLATION AMENDMENT BILL 1987:** The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—  
Debate resumed.  
*Closure:* Mr Humphreys moved—That the question be now put.  
Question—That the question be now put—put and passed.  
And the question—That the Bill be now read a second time—was put accordingly, and passed—Bill read a second time.  
*Message from the Governor-General:* Message No. 249, dated 7 May 1987, from His Excellency the Governor-General was announced recommending an appropriation of revenue for the purposes of the Bill.  
Leave granted for third reading to be moved forthwith.  
Mr Hurford (Minister for Community Services) moved—That the Bill be now read a third time.  
Debate ensued.  
Question—put and passed—Bill read a third time.
  - 3 **INDUSTRIAL RELATIONS BILL 1987:** Mr Willis (Minister for Employment and Industrial Relations), pursuant to notice, presented a Bill for an Act relating to the prevention and settlement of certain industrial disputes, and for other purposes.  
Bill read a first time.  
Mr Willis moved—That the Bill be now read a second time.  
Ordered—That Mr Willis be granted an extension of time.  
*Paper:* Mr Willis presented an explanatory memorandum to the Bill.  
Debate adjourned (Mr Carlton), and the resumption of the debate made an order of the day for the next sitting.
  - 4 **INDUSTRIAL RELATIONS (CONSEQUENTIAL PROVISIONS) BILL 1987:** Mr Willis (Minister for Employment and Industrial Relations), pursuant to notice, presented a Bill for an Act to enact certain transitional provisions, and to amend certain Acts, in consequence of the enactment of the *Industrial Relations Act 1987*, and for other purposes.  
Bill read a first time.  
Mr Willis moved—That the Bill be now read a second time.  
*Paper:* Mr Willis presented an explanatory memorandum to the Bill.  
Debate adjourned (Mr Carlton), and the resumption of the debate made an order of the day for the next sitting.

**5 TAXATION LAWS AMENDMENT (COMPANY DISTRIBUTIONS) BILL 1987:** The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—

Debate resumed by Mr Carlton who moved, as an amendment—That all words after “That” be omitted with a view to substituting the following words: “whilst not declining to give the Bill a second reading, the House—

- (1) condemns the Hawke Labor Government for raising the company tax rate from 46% to 49% at a time when company tax rates around the world are being lowered;
- (2) notes that the Government’s so called ‘tax reform’ proposals have imposed an additional tax burden on business in excess of \$2,000 million;
- (3) notes that these new business taxes have been imposed at a time when the level of business investment in this country has fallen to an appallingly low level and there is a rising tide of bankruptcies;
- (4) notes with concern that the interaction of the proposals in the Bill with the foreign tax credit system and the new capital gains tax imposes a tax disadvantage on companies and on their shareholders;
- (5) notes that the Bill also contains unnecessarily complex administrative and compliance procedures for companies, and therefore
- (6) calls upon the Government to restore the incentive to invest by pursuing a more balanced economic policy and reducing the taxation and administrative burden on business”.

Debate continued.

Mr Rocher addressing the House—

It being 2 p.m., the debate was interrupted in accordance with standing order 101, as amended by sessional order, and the resumption of the debate made an order of the day for a later hour this day.

Mr Howard (Leader of the Opposition) and Mr Sinclair (Leader of the National Party of Australia), by leave, also made statements with reference to the matter.
