- (a) in the circumstances specified in paragraphs 126 (a), (b), (c), (d), (f), (g), (ga), (h), (j), (k) or (m) of the Customs Regulations as in force at the commencement of this subsection;
- (b) where an officer assisted in making up the entry in respect of which the application for a refund of duty is made;
- (c) where an officer assessed the duty payable;
- (d) where the duty was paid under protest;
- (e) where the duty was paid as a consequence of advice given, or a ruling made, by an officer;
- (f) where all duty amounts were paid in good faith;
- (g) where the overpayment of duty was beyond the control of the applicant for the refund; or
- (h) in such other circumstances as may be specified in the regulations.".

15 DOUBLE DISSOLUTION OF THE PARLIAMENT—MINISTERIAL STATEMENT: Mr Hawke (Prime Minister), by leave, made a ministerial statement informing the House that he had today advised His Excellency the Governor-General to exercise his power under section 57 of the Constitution and dissolve both Houses of Parliament on 5 June 1987, with a view to elections for both Houses being held on 11 July 1987. His Excellency accepted the advice, subject to the Parliament appropriating sufficient funds to enable the work of administration to be carried on during the election period.

"whilst not declining to give the Bill a second reading, the House is of the opinion that it unfairly discriminates against hospital patients with private insurance who will receive only 75% of the scheduled fee for medical services, while Medicare patients will continue to receive 85%, so forcing up the cost of private insurance and assisting the Government's objective of forcing more Australians out of private health insurance and making them wait in pain for up to 2 years in the 100,000-long queue for public hospital beds".
