THURSDAY, 21 APRIL 1988

- 1 The House met, at 10 a.m., pursuant to adjournment. Madam Speaker (the Honourable Joan Child) took the Chair, and read Prayers.
- 2 PETITIONS: The Clerk announced that the following Members had each lodged petitions for presentation, viz.:
 - Mr D. M. Cameron, Dr H. R. Edwards, Mr Halverson, Mr Moore and Mrs Sullivan, from 210, 14, 23, 8 and 392 petitioners, respectively, praying that those involved in the public release of confidential medical information be censured.
 - Mr McArthur, from 57 electors of the Division of Corangamite, in similar terms.
 - Mr Brumby, Mr Cleeland, Mr Cunningham and Mr Mildren, from 109, 850, 1344 and 706 petitioners, respectively, praying that due consideration be given to increasing the amount of funds available to local government authorities for roadworks.
 - Mr Beale, Mr Hand and Mr Shack, from 8, 14 and 47 petitioners, respectively, praying that the importation and possession of child pornography be made a criminal offence and certain other action be taken in relation to pornography in the ACT.
 - Dr Blewett, Mr Pratt and Mr Scott, from 38, 78 and 82 petitioners, respectively, praying that the funding level for nursing and personal care staff hours be raised in all States.
 - Mr Chynoweth, Mr Cross and Mr Humphreys, from 28, 17 and 17 petitioners, respectively, praying that any changes to the system of charging for local telephone calls not disadvantage the aged, infirm and other fixed income groups.
 - Mr Beale, from 3 petitioners, praying that the national flag not be changed except by a referendum.
 - Mr Braithwaite, from 24 petitioners, praying that Telecom's proposal to time charge local calls be rejected.
 - Mr Moore, from 18 petitioners, in similar terms.
 - Mr Chynoweth, from 29 petitioners, praying that no action be taken to change the national flag.
 - Mr Dobie, from 52 petitioners, praying that the closure of the Gymea Bay post office, NSW, be prevented.
 - Dr H. R. Edwards, from 65 petitioners, praying that certain action be taken in the ACT in relation to loitering, the consumption of alcohol by underage persons and the production, sale and distribution of material depicting violence.
 - Mr T. A. Fischer, from 43 residents of Albury-Wodonga and surrounding regions, praying that services be restored to the ABC so as not to

disadvantage further non-metropolitan Australians, and that certain other action be taken in relation to the ABC.

Mr Hand, from 9 petitioners, praying that a resolution be passed at the opening of the new Parliament House, acknowledging and affirming certain matters concerning Aboriginals and Torres Strait Islanders.

Mr Humphreys, from 1726 residents of the Division of Griffith, praying that steps be taken to minimise noise levels and alter flight paths at the new Brisbane domestic airport.

Mr Kerr, from 30 petitioners, praying that measures be taken to ensure that the ABC continues to offer comprehensive broadcasting services under its present charter.

Mr Langmore, from 1846 petitioners, praying that the proposal to close Scullin Primary School, ACT, be abandoned.

Mr McArthur, from 28 petitioners, praying that the sale of violent videos, books and toys of violence be banned.

Mr Milton, from 60 petitioners, praying that importation of cobalt 60 and other radioactive substances be banned and regulations permitting irradiation of food in Australia be disallowed.

Mr Scott, from 6 petitioners, in similar terms.

Mr Prosser, from 63 petitioners, praying that legislation be passed to enable the Constitution to be altered to provide for a Citizen Initiated Referendum.

Mr Reith, from 521 residents of the Borough of Wonthaggi, Vic., praying that the decision to discontinue Medicare agency arrangements with Latrobe Health Insurance be reconsidered.

Mr Scott, from 18 petitioners, praying that Australia withdraw from the Asian Regional Co-operative Project on Food Irradiation and from the International Consultative Group on Food Irradiation and certain other action be taken in relation to food irradiation.

Mr Shack, from 28 residents of Western Australia, praying that Telecom's plan to time-charge local telephone calls be abandoned.

Mr Shipton, from 440 petitioners, praying that a referendum on the Australia Card Bill be held before the proposal is resubmitted to Parliament.

Mrs Sullivan, from 143 petitioners, praying that the incidence of crime and violence broadcast on television be reduced.

Mr Tuckey, from 5 petitioners, praying that the Constitutional Initiative (Electors Initiative) Bill 1987 be referred to a parliamentary committee and certain other action be taken in relation to the Bill.

Petitions received.

3 HEALTH INSURANCE AMENDMENT BILL 1988: Mr Tuckey, pursuant to notice, presented a Bill for an Act to amend the *Health Insurance Act 1973*.

Mr Tuckey made a statement in relation to the Bill.

Bill read a first time.

Ordered—That the second reading be made an order of the day for the next sitting Thursday, in accordance with sessional order 104A.

- 4 NEW: RIGHT IN AUSTRALIA: Mr Tickner, pursuant to notice, moved—That this House—
 - (1) views with concern the emergence of the extremist new right in Australia and the increased influence of these forces on Australian institutions and society;
 - (2) believes that this development poses a threat to the well-being of the Australian community; and
 - (3) calls on concerned Australians to unite and participate in the democratic processes in order to preserve the Australian way of life.

 Debate ensued.

The time allotted for the debate having expired, the debate was interrupted, the resumption of the debate made an order of the day for the next sitting Thursday, and Mr Andrew was granted leave to continue his speech when the debate is resumed.

- 5 EMPLOYMENT AND TRAINING PROGRAMS: Mr Lamb, pursuant to notice, moved—That this House supports action to increase employment for all Australians, particularly through—
 - (1) developing training programs to assist young people, the disadvantaged and those affected by technological and structural change; and
 - (2) providing financial support for the development of innovative training schemes designed to assist the Australian workforce to become a highly-skilled part of an internationally competititive economy.

Debate ensued.

- 6 AIRCRAFT NOISE IN BRISBANE: Mr D. M. Cameron, pursuant to notice, moved— That this House—
 - (1) expresses deep concern at the effects of aircraft noise upon several suburbs of the City of Brisbane following the opening of the new Brisbane Airport; and
 - (2) calls upon the Government and the Department of Transport and Communications to take corrective measures immediately.

Debate ensued.

(a) by inserting 'or the Authority' after 'by the Australian Federal Police':

(b) by inserting 'or an officer of the Authority, as the case may be,' after 'of the Australian Federal Police'.".

Bill, as amended, agreed to.
