- 1 The House met, at 10 a.m., pursuant to adjournment.
- 2 ABSENCE OF MADAM SPEAKER: The Clerk having informed the House that Madam Speaker (the Honourable Joan Child) was unavoidably absent, the Chairman of Committees (Mr McLeay) took the Chair as Acting Speaker, and read Prayers.
- 3 ECONOMIC STATEMENT AND REPLY—TELEVISION COVERAGE: Mr Beazley (Leader of the House), pursuant to notice, moved—That this House authorises:
 - (1) the Speaker to make arrangements for all or part of the ministerial statement concerning economic measures to be made by the Treasurer on 25 May 1988 and all or part of the reply to that statement by the Leader of the Opposition to be filmed by the Australian Broadcasting Corporation;
 - (2) the direct, live telecast of all or part of that film and the accompanying sound of the proceedings by any television station provided that a station telecasts both speeches live and gives approximately equal time to both speeches; and
 - (3) the use by any television station of any part of the filmed proceedings and accompanying sound in subsequent news, current affairs and documentary programs.

Question—put and passed.

4 CONSTITUTION ALTERATION (PARLIAMENTARY TERMS) BILL 1988: The order of the day having been read for the resumption of the debate on the question—
That the Bill be now read a second time—

Debate resumed.

Speaker's ruling: Madam Speaker referred to the point of order raised yesterday by the Member for Farrer that the Bill infringed standing order 213 as clause 4 did not come within the long title of the Bill.

Madam Speaker stated that the long title of the Bill provided for 4-year maximum terms for members of both Houses and the detailed provision for this was in clauses 5 and 6. Clause 4 was consequential on clause 5.

The Speaker ruled that clause 4 was not outside the long title and the provisions of standing order 213 had not been breached.

Dissent from ruling moved: Mr Reith moved—That the ruling be dissented from. Debate ensued on the motion of dissent.

 - (a) references in subsection (1) of that section to \$6,142 were references to \$6,384; and
 - (b) references in subsection (1) of that section to \$250 were references to \$308.".

Debate resumed by Mr Beale who moved, as an amendment—That all words after "That" be omitted with a view to substituting the following words: "whilst not declining to give the Bill a second reading, the House condemns the Government for its failure in the transport and aviation areas, and in particular for its failure to:

- (1) provide an appropriate capital base for the two government-owned airlines; and
- (2) address immediately the rorts and inefficiencies on Australian ships and the waterfront".

Further question—That the remaining stages of the Bill be agreed to—put and passed—Bill read a third time.
