- 2 RESIGNATION OF MEMBER AND ISSUE OF WRIT—OXLEY DIVISION: Madam Speaker announced that she had, on 17 August 1988, received a letter from the Honourable Bill Hayden resigning his seat as Member for the electoral division of Oxley in the State of Queensland. Madam Speaker stated that she intended to issue a writ on 5 September 1988 for the election of a Member to serve for the said electoral division. The dates in connection with the election would be fixed as follows:

Close of rolls—Monday, 12 September 1988. Nomination—Friday, 16 September 1988. Date of polling—Saturday, 8 October 1988. Return of writ—On or before Wednesday, 14 December 1988.

- 3 DEATHS OF FORMER MEMBER (MR F. OLLEY) AND FORMER SENATOR (MR R. E. MCAULIFFE): Madam Speaker informed the House of the deaths of Mr Frank Olley, on 21 July 1988, a Member of this House for the Division of Hume from 1972 to 1974, and Mr Ronald Edward McAuliffe, OBE, on 16 August 1988, a Senator for the State of Queensland from 1971 to 1981.
 - As a mark of respect to the memory of the deceased all Members present stood, in silence.
- 4 SUSPENSION OF STANDING AND SESSIONAL ORDERS—GOVERNMENT BUSINESS NOTICE: Mr Beazley (Leader of the House), pursuant to notice, moved—That so much of the standing and sessional orders be suspended as would prevent notice No. 2, government business, being called on forthwith. Question—put and passed.
- 5 ABORIGINES AND TORRES STRAIT ISLANDERS—SETTLEMENT AND PLACE IN AUSTRALIA: Mr Hawke (Prime Minister), pursuant to notice, moved—That this House—
 - (1) acknowledges that:
 - (a) Australia was occupied by Aborigines and Torres Strait Islanders who had settled for thousands of years before British settlement at Sydney Cove on 26 January 1788;
 - (b) Aborigines and Torres Strait Islanders suffered dispossession and dispersal upon acquisition of their traditional lands by the British Crown; and
 - (c) Aborigines and Torres Strait Islanders were denied full citizenship rights of the Commonwealth of Australia prior to the 1967 referendum;
 - (2) affirms:
 - (a) the importance of Aboriginal and Torres Strait Islander culture and heritage; and

- (b) the entitlement of Aborigines and Torres Strait Islanders to selfmanagement and self-determination subject to the Constitution and the laws of the Commonwealth of Australia: and
- (3) considers it desirable that the Commonwealth further promote reconciliation with Aboriginal and Torres Strait Islander citizens providing recognition of their special place in the Commonwealth of Australia.
- Mr Howard (Leader of the Opposition) moved, as an amendment—That after the words "the entitlement of Aborigines and Torres Strait Islanders to self-management and self-determination" in paragraph (2) (b) the following words be inserted: ", in common with all other Australians,".
