17 MESSAGE FROM THE SENATE—LANDS ACQUISITION BILL 1988: The following message from the Senate was reported:

Message No. 318

Madam Speaker,

The Senate returns to the House of Representatives the Bill for "An Act relating to the acquisition of land by the Commonwealth and certain authorities and dealings with land so acquired, and for other purposes", and acquaints the House that the Senate has agreed to the Bill with the Amendments indicated by the annexed Schedule, in which Amendments the Senate requests the concurrence of the House of Representatives.

The Senate, Canberra, 5 April 1989 Ordered—That the amendments be taken into consideration, in committee of the whole House, forthwith.

SCHEDULE OF THE AMENDMENTS MADE BY THE SENATE

- No. 1—Page 2, subclause 5 (2), lines 13 to 18, leave out the subclause, insert the following subclause:
 - "(2) If a provision referred to in section 21A of the *Christmas Island Act* 1958 is in operation, this Act does not apply to anything dealt with by the provision."
- No. 2—Page 3, clause 6, definition of "Commonwealth authority", paragraph (a), lines 1 to 3, leave out the paragraph, insert the following paragraph:
 - "(a) that is incorporated by or under a law of the Commonwealth or by or under a law of a Territory, other than:
 - (i) an enactment as defined by section 3 of the Australian Capital Territory (Self-Government) Act 1988;
 - (ii) a law of the Northern Territory; or
 - (iii) a law of Norfolk Island; and".
- No. 3—Page 52, clause 119, lines 33 to 37, leave out the clause, insert the following clause:

Disposal of interests in land

- "119. (1) An interest in land vested in an acquiring authority may be disposed of under the written authority of the Minister.
- "(2) A person dealing with an acquiring authority is not concerned to inquire whether this Part has been complied with, and the vesting in a person of an interest in land is not affected by any contravention of this Part.".
- No. 4—Page 56, subclause 124 (8), line 39, leave out "subsection 53 (2A)", insert "subsections 53 (2) and (2A)".
- No. 5—Page 57, subclause 125(1), lines 5 and 6, leave out "shall not, without the written authority of the Minister, acquire an interest in overseas land", insert "shall not acquire an interest in overseas land otherwise than in accordance with this section".
- No. 6—Page 57, subclause 125 (2), lines 14 and 15, leave out "shall not, without the written authority of the Minister, dispose of an interest in land", insert "shall not dispose of an interest in overseas land otherwise than in accordance with this section".
- No. 7—Page 57, after subclause 125 (2), insert the following new subclause:
 - "(2A) An interest in overseas land may be acquired or disposed of by an acquiring authority under the written authority of the Minister.".
- No. 8—Page 57, subclause 125 (5), lines 38 and 39, leave out the subclause.
- No. 9-Page 60, clause 130, line 4, leave out "and 129", insert ", 129 and 133".
- No. 10—Page 62, subclause 137 (1), line 18, leave out "such address as is prescribed", insert "an address prescribed for the purposes of this subsection".
- No. 11—Page 63, subclause 139 (1), lines 13 to 15, leave out the subclause, insert the following subclause:
 - "(1) Subject to subsection (2), the Minister or the Attorney-General may, in writing, delegate all or any of his or her powers and functions under this Act to:
 - (a) a member of the Australian Public Service; or
 - (b) a person who has executive authority in relation to the affairs of a Commonwealth authority.".
- On the motion of Mr West (Minister for Administrative Services), the amendments were agreed to.

- 20 MILITARY POLICE COMPLEX, GREEN HILLS, LIVERPOOL MILITARY AREA, NSW—DEVELOPMENT—APPROVAL OF WORK: Mr West (Minister for Administrative Services), pursuant to notice, moved—That, in accordance with the provisions of the Public Works Committee Act 1969, it is expedient to carry out the following proposed work which was referred to the Parliamentary Standing Committee on Public Works and on which the committee has duly reported to Parliament: Development of a military police complex at Green Hills, Liverpool Military Area, NSW.

Debate ensued.

- 21 ECONOMIC STATEMENT AND REPLY—TELEVISION COVERAGE: Mr West (Minister for Administrative Services), for Mr Beazley (Leader of the House), pursuant to notice, moved—That this House authorises:
 - (1) the Speaker to make arrangements for all or part of the ministerial statement concerning economic measures to be made by the Treasurer on 12 April 1989 and all or part of the reply to that statement by the Leader of the Opposition to be televised;
 - (2) the direct, live telecast of all or part of that film and the accompanying sound of the proceedings by any television station provided that a station telecasts both speeches live and gives approximately equal time to both speeches; and
 - (3) the use by any television station of any part of the filmed proceedings and accompanying sound in subsequent news, current affairs and documentary programs.

Question—put and passed.

- 22 APPROPRIATION BILL (NO. 3) 1988-89: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—
 - Debate resumed by Dr Hewson who moved, as an amendment—That all words after "That" be omitted with a view to substituting the following words: "whilst not declining to give the Bill a second reading, the House notes that:
 - (1) budget estimates put Commonwealth Government outlays at over a quarter of Australia's GDP, and that this is funded by revenue collection that has made this the highest taxing Government in the post-war history of Australia.
 - (2) the Government's budget strategy is in tatters with its key forecasts on inflation εnd the balance of payments wildly off-track;
 - (3) the Government is locked into a strategy of sole reliance on monetary policy and high interest rates to bring the economy back on track with the result that home loan interest rates are now at their highest level in Australia's history; and
 - (4) the process of micro-economic reform has stalled with the Government either stopping or delaying much needed structural policies which are crucial if Australia is to increase productivity and to reduce its unsustainably high level of foreign debt".

Debate continued.
