(1) this House authorises the broadcasting by ABC TV of Question Time

for a trial period from 21 August to 18 October 1990;

- (2) the distribution of the broadcast between the two Houses be in accordance with the distribution of the radio broadcast, provided the Senate is broadcast on no less than three days in any two week sitting period; and
- (3) this House authorises the broadcasting by television stations of excerpts of proceedings in accordance with the following conditions:
 - (a) access to the proceedings of the House of Representatives for the recording and broadcasting of excerpts of proceedings is subject to an undertaking to observe, and to comply with, these conditions;
 - (b) recordings and broadcasts may be made only from Channel 1 on the House monitoring system;
 - (c) broadcasts of excerpts shall be used only for the purposes of fair and accurate reports of proceedings, and shall not be used for:
 - (i) political party advertising or election campaigns;
 - (ii) satire and ridicule; or
 - (iii) commercial sponsorship or commercial advertising;
 - (d) reports of proceedings shall be such as to provide a balanced presentation of differing views;
 - (e) excerpts of proceedings which are subsequently withdrawn may be broadcast only if the withdrawal is also reported;
 - (f) debate on a motion for the adjournment of the House of Representatives shall not be broadcast; and
 - (g) the instructions of the Speaker of the House of Representatives or his delegates in respect of the broadcasting of excerpts, which are not inconsistent with these conditions, shall be observed; and
- (4) the conditions contained in subparagraph 3 (c) be referred to the Procedure Committee for inquiry and report by 21 August 1990, and that these orders have effect until altered by a further order of the House of Representatives in relation to a report of the Procedure Committee.
