- 1 The House met, at 10 a.m., pursuant to adjournment. Mr Speaker (the Honourable Leo McLeay) took the Chair, and read Prayers.
 - 2 **NOTICE PAPER—STATEMENT BY MR SPEAKER:** Mr Speaker referred to the report of the Procedure Committee on greater opportunities for debate on reports from parliamentary committees presented on 11 October 1990. Mr Speaker informed the House that, as recommended by the Procedure Committee in its report, the Notice Paper had been rearranged so that orders of the day for the resumption of debate on motions moved in relation to committee or delegation reports appear in a discrete section of the Notice Paper.
 - 3 **PETITIONS:** The Clerk announced that the following Members had each lodged petitions for presentation, viz.:
 - Mr Beale and Mr Willis, from 663 and 58 petitioners, respectively, praying for a twelve month moratorium followed by a referendum to enable the citizens of Australia to consider and decide whether the United Nations Convention on the Rights of the Child should be ratified.
 - Mr Anderson, from 22 petitioners, praying that consideration of the proposed Multifunction Polis be suspended, pending exhaustive public debate and full public disclosure of the nature and details of the proposal.
 - Mr Andrew, from 5849 petitioners, praying that the original criteria for assessing eligibility for family allowance and assets test levels in relation to Austudy be retained.
 - Mr Bevis, from 13 petitioners, praying that an International Earth Repair Action Decade begin on 5 June 1990.
 - Mr Fife, from 125 petitioners, praying that legislative action be taken to protect the present Australian coat of arms and national flag and to impose certain penalties for the abuse of those symbols.
 - Mrs Gallus, from 721 petitioners, praying that steps be taken to reduce the high level of petrol prices and excise.
 - Mr Mack, from 2189 petitioners, praying that action be taken to phase out the consumption, production and export of chlorofluorocarbons and halons.
 - Mr Mack, from 482 petitioners, praying that a charge on pensioners' prescriptions not be introduced.
 - Mr McArthur, from 22 petitioners, praying that the Otway Forests, Vic., be managed in the best interests of the Australian people and that the export woodchip licence granted to Midway Wood Products be rescinded.

and imprisonment as well as over all officials authorised by law to use force and firearms; and

- (4) urges the Australian Government to seek whatever ways are appropriate to bring a halt to all human rights abuses carried out by all armed parties in Sri Lanka and urges all parties involved to exercise maximum restraint.

Debate ensued.
