## THURSDAY, 15 NOVEMBER 1990

- 1 The House met, at 10 a.m., pursuant to adjournment. Mr Speaker (the Honourable Leo McLeay) took the Chair, and read Prayers.
- 2 PETITIONS: The Clerk announced that the following Members had each lodged petitions for presentation, viz.:
  - Mr Andrew and Mr Downer, from 1101 and 63 petitioners, respectively, praying that the original criteria for assessing eligibility for family allowance and assets test levels in relation to Austudy be retained.
  - Mr Andrew, from 109 petitioners, in similar terms.
  - Mr Beale and Mr Reid, from 173 and 248 petitioners, respectively, praying that the United Nations Convention on the Rights of the Child not be ratified.
  - Mr Downer, Mrs Gallus, Mr Halverson and Mr Newell, from 85, 170, 146 and 73 petitioners, respectively, in similar terms.
  - Ms McHugh and Mr MacKellar, from 20 and 17 petitioners, respectively, praying that the Therapeutic Goods Regulations be rejected and a public inquiry held into the registration of natural medicines.
  - Mr Anderson, from 45 petitioners, praying that consideration of the proposed Multifunction Polis be suspended, pending exhaustive public debate and full public disclosure of the nature and details of the proposal.
  - Mr Andrew, from 22 petitioners, praying that methods other than high interest rates be explored to reduce balance of trade problems.
  - Mr Beale, from 45 petitioners, praying for a twelve month moratorium followed by a referendum to enable the citizens of Australia to consider and decide whether the United Nations Convention on the Rights of the Child should be ratified.
  - Mr Prosser, from 45 petitioners, in similar terms.
  - Dr Catley, from 169 residents of South Australia, praying that action be taken to prevent a reduction of funding for public housing in South Australia.
  - Mrs Crosio, from 8 petitioners, praying that certain action be taken to support and restore national and human rights to the Serbian people in the Kosovo area.
  - Mr Dobie, from 21 petitioners, praying that funding of abortions through Medicare cease and certain other action be taken to protect the right to life of the unborn.
  - Mr Dobie, from 11 petitioners, praying that the importation and availability of pornography in videos, films and television be banned and certain other action be taken in relation to pornography.
  - Mr Downer, from 17 petitioners, praying that the Therapeutic Goods Regulations be rejected and a public inquiry held into the registration

of the natural healing profession and regulation of natural therapeutic

goods.

Mr Johns, from 1507 petitioners, praying that women who served in the armed forces in Australia during World War II be paid a service pension and receive treatment similar to war widows in respect of medical and other benefits.

Mrs Kelly, from 22 petitioners, praying that the Otway Forests, Vic., be managed in the best interests of the Australian people and that the export woodchip licence granted to Midway Wood Products be rescinded.

Ms McHugh, from 80 petitioners, praying that any attempt to restrict access to abortion under Medicare be opposed.

Ms McHugh, from 16 petitioners, praying that action be taken to re-

negotiate the Treaty of Trianon (1920).

Mr Mack, from 13 420 petitioners, praying that action be taken to phase out the consumption, production and export of chlorofluorocarbons and halons.

Mr Mack, from 495 petitioners, praying that a charge on pensioners' prescriptions not be introduced.

Mr Mack, from 11 petitioners, praying that the Shark Bay region, WA, be declared a national park and nominated for World Heritage listing.

Mr MacKellar, from 11 petitioners, praying for legislation to make Coronation Hill part of Kakadu National Park.

Mr Moore, from 31 residents of Queensland, praying that the ABC be provided with adequate funding to enable ABC TV daytime educational programs to continue.

Mr Nehl, from 147 petitioners, praying that the position of the family as the basic unit of society be ensured and that certain other action be taken to maintain traditional family values.

Mr Newell, from 136 petitioners, praying for an immediate moratorium on logging in the "Great Sandy Region" on Fraser Island.

Mr Prosser, from 36 residents of Western Australia, praying that the recently introduced assets test on family allowance payments be opposed.

Mr B.C. Scott, from 403 electors of the Division of Maranoa, praying that the assets test on family allowance and assistance for isolated children be abolished and that the decision to reduce the assets test for Austudy and the family allowance supplement be reconsidered.

Mrs Sullivan, from 35 petitioners, praying that the United Nations Convention on the Rights of the Child be ratified in a form which protects children from abuse and exploitation and pays the highest regard to the family unit and responsibilities of parents.

Mr Wilson, from 10 petitioners, praying that an opposition party or any reasonably large group of electors be allowed to submit referendum auestions.
