WEDNESDAY, 6 MARCH 1991

- 1 The House met, at 10 a.m., pursuant to adjournment. Mr Speaker (the Honourable Leo McLeay) took the Chair, and read Prayers.
- 2 AUSTRALIAN HORTICULTURAL CORPORATION AMENDMENT BILL 1990: The House, according to order, resolved itself into a committee of the whole for the further consideration of the Bill.

In the committee

Clause 2 agreed to.

Remainder of Bill, by leave, taken as a whole.

On the motion of Mr Hand (Minister for Immigration, Local Government and Ethnic Affairs), by leave, the following amendments were made together, after debate:

Amendments—

Clause 17—

Page 16, proposed subsection 115G (1), line 38, after "financial year" insert "after the financial year in which it was established.".

Page 17, proposed subsection 115G (3), lines 2 and 3, omit all the words after "has effect as if", substitute "the Board had been established during the next financial year".

Page 17, lines 34 to 41, and page 18, lines 1 to 8, omit proposed section 115K, substitute the following section:

"'115K. The purpose of a Board's annual general meeting is to provide an opportunity for the payers of a levy or export charge related to the Board:

- (a) to consider a report by the Chairperson of the Board on the activities of the Board since its establishment or its last annual general meeting, as the case requires; and
- (b) to consider any audited financial statement of the Board produced since its establishment or its last annual general meeting, as the case requires; and
- (c) to consider a report by the Chairperson of the Corporation on the activities of the Corporation since the Board was established or since the Board's last annual general meeting, as the case requires; and
- (d) to debate, and vote upon, any motion that the Board recommend to the Minister that a variation be made to a levy or to an export charge; and
- (e) to debate, and vote upon, any motion of no confidence in the Board or its Chairperson.".

Page 20, proposed subsection 115Q (2), line 31, omit "regulation", substitute "regulations".

Clause 24, page 27, line 39, omit "is", substitute "and the *Dried Fruits Export Charges Act 1924* are".

New clauses—

Page 29, after clause 30 insert the following new clause:

Rates of charge

"30A. Section 7 of the Principal Act is amended by inserting in subsection (1) '8A,' after '8,'.".

Page 30, after clause 31 insert the following new clauses:

Flexibility in relation to rates of charge

"31A. Section 11 of the Principal Act is amended:

(a) by inserting '8A,' after '8,';

(b) by omitting from paragraph (c) '2' and substituting 'more'.

Regulations

"31B. Section 14 of the Principal Act is amended by inserting

after subsection (3) the following subsection:

'(3A) Before making regulations for the purposes of section 8A, the Governor-General is to take into consideration any relevant recommendation made to the Minister by the Product Board concerned.'."

Clause 33, page 30, proposed paragraph 11 (2A) (b), line 22, omit "115P", substitute "115Q".

New clauses—

Page 30, after clause 34 insert the following new clause:

Rates of levy

"34A. Section 7 of the Principal Act is amended by inserting in subsection (1) '8A,' after '8,'.".

Page 30, after clause 35 insert the following new clauses:

Flexibility in relation to rates of levy

"35A. Section 11 of the Principal Act is amended:

(a) by inserting '8A,' after '8,';

(b) by omitting from paragraph (c) '2' and substituting 'more'.

Regulations

"35B. Section 14 of the Principal Act is amended by inserting

after subsection (3) the following subsection:

'(3A) Before making regulations for the purposes of section 8A, the Governor-General must take into consideration any relevant recommendation made to the Minister by the Product Board concerned.'."

Amendment-

Clause 37, page 31, proposed paragraph 11 (2A) (b), line 16, omit "115P", substitute "115Q".

Bill, as amended, agreed to.

Bill to be reported with amendments.
