- 1 The House met, at 10 a.m., pursuant to adjournment.
- 2 **ABSENCE OF SPEAKER:** The Clerk having informed the House that Mr Speaker (the Honourable Leo McLeay) was absent, the Chairman of Committees (Mr R. F. Edwards) took the Chair as Acting Speaker, and read Prayers.
- 3 **ALBURY-WODONGA DEVELOPMENT AMENDMENT BILL 1991:** The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—  
 Debate resumed by Mr Braithwaite who moved, as an amendment—That all words after “That” be omitted with a view to substituting the following words: “whilst not declining to give the Bill a second reading, the House is of the opinion that the functions of the Albury-Wodonga Development Corporation should be phased out as soon as practicable, but notes that the Bill does not provide for this”.  
 Debate continued.  
 Amendment negatived.  
 Question—That the Bill be now read a second time—put and passed—Bill read a second time.

- Clause 8, page 15, proposed sub-clause 9(1), omit "growth centre", substitute "growth complex".
- Clause 9, page 16, proposed clause 10, omit "growth centre", substitute "growth complex".
