# THURSDAY, 6 MAY 1993

1 The House met, at 9.30 a.m., pursuant to adjournment. The Speaker (the Honourable Stephen Martin) took the Chair, and read Prayers.

### 2 PETITIONS

The Clerk announced that the following Members had each lodged petitions for presentation, viz.:

Mr Anderson, Mr Cobb, Mr Lloyd and Mr Truss, from 703, 15, 8 and 149 petitioners, respectively, praying that the current national flag be preserved and no change be made to its design unless supported by referendum by the majority of Australians in the majority of States.

Mr J. N. Andrew, Mr Connolly and Mr Jull, from 170, 35 and 70 petitioners, respectively, praying that no action be taken to change the national flag unless approved by the people of Australia in a national poll.

Mr Lloyd, Mr McGauran and Mr Reith, from 57, 11 and 90 residents of Victoria, respectively, praying that Medicare funding of abortion be terminated by support for the Abortion Funding Abolition Bill 1990.

Mr Dobie and Mr Ruddock, from 22 and 463 petitioners, respectively, praying that no change be made to the design or colour of the Australian national flag and that it continue to represent a true manifestation of the nation's history.

Mr Mack and Mr Moore, from 324 and 20 petitioners, respectively, praying that the proposed ABC television service to Asia be wholly funded by the Government or that the service not commence until Government funds are available.

Mr MacKellar and Mr Tickner, from 7 and 18 petitioners, respectively, praying that legislative action be taken to implement the Earth Repair Charter.

Mr Anderson, from 244 petitioners, praying that the existing Australian flag be retained and Australians be given the opportunity to express that wish through a referendum.

- Mr J. N. Andrew, from 923 petitioners, praying that capital punishment be re-introduced for serious crimes committed against innocent victims.
- Mr J. N. Andrew, from 104 petitioners, praying that the Civil Aviation Authority not be allowed to require gliders to carry Mode C transponders.

Mr J. N. Andrew, from 17 petitioners, praying that tax credits or rebates be provided to encourage private health care funding where it can be afforded.

Mr Beale, from 93 petitioners, praying that no change be made to the national flag without a full referendum.

Mr Beale, from 9 petitioners, praying that legislation preventing the right to advertise electoral material on radio and television be rejected.

Mr Bradford, from 35 petitioners, praying that the House affirm its support for the Australian flag and that the flag not be changed.

Mr Braithwaite, from 851 residents of Queensland, praying that certain action be taken in relation to the provision of television services to the Collinsville district, Qld, following aggregation.

Mr Braithwaite, from 61 petitioners, praying that the plastic five dollar note be withdrawn from circulation and replaced with a paper note similar to the previous one.

Mr Fischer, from 5221 petitioners, praying that action be taken to ensure that the registered publications service is saved.

Mr Fischer, from 74 petitioners, praying that the new five dollar note be reviewed.

Mr Howard, from 348 petitioners, praying that Medicare funding of abortion be terminated and the practice be outlawed.

Mrs Kelly, from 975 petitioners, praying that certain action be taken in response to the shipment of plutonium from France to Japan.

Dr Kemp, from 21 petitioners, praying that the Australian National University Amendment (Autonomy) Bill 1992 be debated and passed in the House at the earliest opportunity.

Mr Langmore, from 360 petitioners, praying that action be taken to ensure that Serbian Chetniks do not take part in future Anzac Day marches.

Mr Lindsay, from 146 residents of Queensland, praying that the program of certain roadworks in Townsville be accelerated.

Mr Lloyd, from 127 users of the services of the Australian and Overseas Telecommunications Corporation (AOTC), praying that existing AOTC residential customer service offices in the city and country be kept open and AOTC be stopped from cutting staff in the residential customer service area.

Mr O'Keefe, from 228 petitioners, praying that the Family Law Act be amended to re-introduce adultery as a ground for divorce.

Mr O'Keefe, from 57 petitioners, praying that importation of goods supported by subsidies and other non-tariff or dumping measures be stopped and that tariffs remain in place while other nations use such measures.

Mr Peacock, from 32 petitioners, praying that no further reductions in funding for the ABC be agreed to.

Mr Reid, from 176 petitioners, praying that legislation which enables the Industrial Relations Commission to interfere in contracts between builders and subcontractors be repealed.

Mr Simmons, from 101 petitioners, praying that Australia Post's current mechanisms for price constraints be supported.

Mr Walker, from 529 petitioners, praying that the Indonesian Government be persuaded to bring a speedy end to suffering in East Timor.

Mr Walker, from 33 petitioners, praying that all members of the United Nations be called upon to end the financial, commercial and economic blockade on Cuba.

Ms Worth, from 13 petitioners, praying that certain action be taken to restore profitability to Australian farms and factories, and provide employment opportunities to Australians and a future for youth.
