1 The House met, at 9.30 a.m., pursuant to adjournment. The Speaker (the Honourable Stephen Martin) took the Chair, and read Prayers.

2 PETITIONS

The Clerk announced that the following Members had each lodged petitions for presentation, viz.:

Mr Anderson and Mrs Moylan, from 378 and 12 petitioners, respectively, praying that no change be made to the design or colour of the Australian national flag and that it continue to represent a true manifestation of the nation's history.

Mr Beale and Mr Nugent, from 153 and 441 petitioners, respectively, praying that the lifting of the arms embargo against the Bosnian Government and the bombing of military targets in Serbian held territories be supported.

Mr Beale, from 76 petitioners, praying that the need for dementia specific hostels and their funding be affirmed and that an independent committee be set up to inquire into the care and cost benefits of such hostels.

Mr Dawkins, from 215 petitioners, praying that the deportation order served against Mr Ah Hin Teoh be withdrawn.

Mr Howard, from 17 petitioners, praying that certain action be taken before 1 January 2001 to reaffirm that Australia is a Christian Commonwealth according to law and its heritage, traditions and customs.

Mr Langmore, from 427 petitioners, praying that stronger representations be made to the Government of the Socialist Republic of Vietnam concerning allegations of religious intolerance and the intervention and oppression of religious organisations, especially the United Vietnamese Buddhist Congregation.

Mr Mack, from 98 petitioners, praying that tax credits or rebates be provided to encourage private health care funding where it can be afforded.

Mr Mack, from 30 petitioners, praying that the use of genetic engineering and cloning of human beings, animals, plant life, microbes and foods be prohibited.

Mr Nehl, from 27 petitioners, praying that any increase in charges for postage of magazines and newspapers by Australia Post be prevented.

Mr Somlyay, from 227 residents of Queensland, praying that the Beall family of Noosa, Qld, be permitted residency status.

The Speaker stated that the information available to him did not indicate that a matter of privilege or contempt existed and, as no *prima facie* case had been made out, he was not willing to give precedence to a motion in relation to the matter.

- (3) calls upon the Australian Government to persuade the Indonesian Government to comply with paragraph 9 of the resolution by enabling the UN special rapporteurs on torture and on extrajudicial, summary or arbitrary executions and the UN working group on arbitrary detention and on enforced or involuntary disappearances to discharge their mandates in accordance with the terms of the resolution; and
- (4) welcomes the resumption of talks under the auspices of the Secretary-General of the UN to arrive at a just, comprehensive and internationally acceptable solution to the question of East Timor.

10 HUMAN RIGHTS IN VIETNAM

(1) notes the visit of Mr Vo Van Kiet, Prime Minister of the Socialist Republic of Vietnam to Australia, and deplores his Government's record of substantial human rights abuses; and

- (2) calls on the Government to:
 - (a) immediately and unconditionally release all political prisoners and prisoners of conscience, including the Venerable Thich Huyen Quang;
 - (b) introduce basic human rights to Vietnam, including freedom of assembly, religious worship and speech, a free press and free and open elections;
 - (c) provide for the creation of a pluralist free enterprise economy; and
 - (d) demonstrate to the Parliament of Australia how and where aid monies provided to Vietnam by Australia are spent and how that aid encourages the cultivation of a more democratic and free society in Vietnam.

Constitutional significance of Senate amendment No. 2-Statement by Speaker

The Speaker made the following statement:

It is again my duty to advise the House that an amendment of the Senate needs to be considered in light of the requirements of the Constitution.

As I understand it, by its second "amendment" to this Bill, the Senate would have the *Sales Tax Assessment Act 1992* amended in such a way that would, effectively, increase certain liabilities for the payment of sales tax (although some offsets will be allowed).

The third paragraph of section 53 of the Constitution provides that the Senate "may not amend any proposed law so as to increase any proposed charge or burden on the people".

The history of the consideration on this provision, as between the Houses, contains many references to proposals concerning Commonwealth <u>expenditure</u>. It can however be argued that the phrase "charge or burden on the people" may also be read as encompassing measures relating to <u>taxation</u>.

The second paragraph of section 53 prohibits the Senate from amending proposed laws <u>imposing</u> taxation. Still the Senate is not prevented from amending laws which merely <u>relate</u> to taxation—that is bills which in themselves do not actually impose taxation.

The issue for the House, when faced with a Senate "amendment" to a bill relating to taxation (such as the present Bill), is to consider whether it regards the amendment as increasing any "proposed charge or burden on the people".

On the information available to me, and having regard to the opinions of eminent counsel on the constitutional provision, it would seem that the effect of the second of the Senate amendments to this Bill should be seen as increasing a charge or burden on the people. The House may regard this as infringing the limitations imposed on the Senate by the Constitution.

Again it is for the House to consider what action it may wish to take on this matter.

- (1) the House endorses the statement of the Speaker in relation to the constitutional questions raised by Message No. 35 transmitted by the Senate in relation to the Taxation Laws Amendment Bill (No. 2) 1993;
- (2) the House, having regard to the fact that the public interest demands the early enactment of the legislation, refrains from the determination of its constitutional rights in respect of Senate message No. 35;
- (3) should the House concur in the amendments transmitted in Senate message No. 35, the Speaker's statement and parts (1) and (2) of this resolution be incorporated in the message returning the Bill to the Senate; and
- (4) the amendments be taken into consideration, in committee of the whole House, forthwith.

"Division 1—Principal Act

Principal Act

"65. In this Part, 'Principal Act' means the Sales Tax Assessment Act 1992.

"Division 2—Amendments relating to contents of containers

Taxable dealing with goods that are the contents of a container

"66. Section 35 of the Principal Act is amended by omitting subsection (4) and substituting the following subsection:

'(4) This section does not apply if the container is a shipping container covered by exemption Item 60.'.

Schedule 1

"67. Schedule 1 to the Principal Act is amended:

(a) by omitting all the words in column [3] of Table 3 in relation to CR7 and substituting:

'Claimant is the taxpayer for an assessable dealing with goods ("the **output goods**") that is not taxable (for any reason except section 29). Claimant has borne tax on other goods ("the input goods") that have a sufficient link (as defined by section 52) with the output goods. The input goods are not covered by exemption Item 27(3).';

(b) by inserting after credit ground CR8 in Table 3 the following credit ground:

has borne tax on the container.

On the motion of Mr Gear (Assistant Treasurer), the amendments were agreed to, after debate.
