Mr Beale, Mr Evans, Mr Jull and Mr Reid, from 9, 117, 2 and 8 petitioners, respectively, praying that measures to treat unrealised capital gains and losses on listed securities as income under the *Social Security Act 1991* and the *Veterans' Entitlements Act 1986* be abandoned.

Mr McArthur, Mr Ruddock, Mr Wakelin and Mr Williams, from 2, 20, 53 and 25 petitioners, respectively, in similar terms.

Ms Fatin, Mr Swan, Mr Tuckey and Mr Vaile, from 191, 264, 19 and 76 petitioners, respectively, praying that Medicare continue to be a universal health insurance system and that eye tests be covered.

Mr Sawford, from 41 petitioners, in similar terms.

Mr J. N. Andrew, Dr Kemp and Mrs Sullivan, from 283, 433 and 763 petitioners, respectively, praying that the increases in petrol excise proposed in the 1993-94 Budget be opposed.

Mr Andrew and Ms Worth, from 17 133 and 876 petitioners, respectively, praying that the proposal to increase the level of wholesale sales tax on wine from 20 to 31 per cent be abandoned.

Mr Duffy and Mrs Gallus, from 391 and 122 petitioners, respectively, praying that the lifting of the arms embargo against the Bosnian Government and the bombing of military targets in Serbian held territories be supported.

Mr Fischer and Mr Slipper, from 1068 and 22 petitioners, respectively, praying that no change be made to the design or colour of the Australian national flag and that it continue to represent a true manifestation of the nation's history.

Ms Henzell and Mr Swan, from 804 and 380 petitioners, respectively, praying that the proposal to exclude non health care card holders and pensioners from claiming benefits for eye examinations from optometrists and ophthalmologists be abandoned.

Mr Cameron, from 17 petitioners, praying that importation of goods supported by subsidies and other non-tariff or dumping measures be stopped and that tariffs remain in place while other nations use such measures.

Mr Costello, from 66 petitioners, praying that the amount of excise on tobacco be restored to the levels announced in the 1993-94 Budget.

Mr Downer, from 197 petitioners, praying that the increases in wholesale sales tax, petrol excise, tax on wine and tax on lump sums received for unused leave proposed in the 1993-94 Budget be rejected.

Mr Downer, from 117 petitioners, praying that tax credits or rebates be provided to encourage private health care funding where it can be afforded.

Mr Forrest, from 537 petitioners, praying that the increased sales tax on wine be abolished.

Mr Gear, from 48 residents of Western Australia, praying that certain action be taken to enable Aboriginal people who have maintained links with particular lands to have their rights at law recognised and enforced.

Mr Halverson, from 993 petitioners, praying that the proposal to increase the level of wholesale sales tax on wine from 20 to 31 per cent be rejected.

Ms Henzell, from 550 petitioners, praying that Higher Education Contribution Scheme rates not be increased.

Ms Henzell, from 20 petitioners, praying that legislative action be taken to implement the Earth Repair Charter.

Mr Kerr, from 727 petitioners, praying that the divisions of Oceanography, Fisheries and Atmospheric Research be retained within CSIRO and the proposed amalgamation of marine science bodies be rejected.

- (3) the retention of their culture, arts and heritage; and
- (4) that descendants of South Sea Islanders remain proud Australians.

## 6 PRIME MINISTER'S REWRITING OF AUSTRALIAN HISTORY

Mr Filing, pursuant to notice, moved—That this House:

- (1) deplores the Prime Minister's constant rewriting of Australian history to suit his own political purposes;
- (2) particularly deplores the Prime Minister's denigration of the Menzies years, a period of growth, employment and stability where Australia developed a strong national identity that reflected its role as a positive and beneficial influence in its region; and
- (3) contrasts the Prime Minister's own legacy of record unemployment, economic decline, massive debt, rampant crime, family breakdown and a society where many feel alienated and powerless.

Debate ensued.

Debate adjourned, and the resumption of the debate made an order of the day for the next sitting Thursday.

## 7 WHOLESALE SALES TAX ON WINE

Mr J. N. Andrew, pursuant to notice, moved—That this House:

- (1) is of the opinion that the effect of the increase in wholesale sales tax on wine will be to:
  - (a) slash revenue from domestic wine sales by \$100 million;
  - (b) reduce the income of grape growers;
  - (c) inevitably lead to the loss of jobs in vineyards, wine production, packaging, transport and marketing;
  - (d) inevitably lead to the demise of approximately 140 of Australia's 738 wineries; and
  - (e) force 500 grape growers to leave the wine industry; and
- (2) calls on the Government to reverse its decision to increase the wholesale sales tax on wine.

Debate ensued.

It being 12.30 p.m., the debate was interrupted in accordance with standing order 104A, the resumption of the debate made an order of the day for the next sitting Thursday, and Mr Wakelin was granted leave to continue his speech when the debate is resumed.
