1 The House met, at 9.30 a.m., pursuant to adjournment. The Speaker (the Honourable Stephen Martin) took the Chair, and read Prayers.

2 PETITIONS

The Clerk announced that the following Members had each lodged petitions for presentation, viz.:

Mr Anderson, Mr Cobb, Mr Sharp and Mr Simmons, from 822, 33, 16 and 8 petitioners, respectively, praying that action be taken to ensure the continued availability of high octane petrol to Australian motorists.

Mr Evans, Mrs Moylan, Mr Prosser and Mr Williams, from 109, 104, 15 and 35 petitioners, respectively, praying that the outcome of the Mabo decision be decided by referendum.

Mr Cameron, from 23 residents of Western Australia, and Mr Lieberman, from 414 residents of the Division of Indi and 255 petitioners, respectively, praying that expanded mammography services be introduced and covered by medical benefits.

Mr Evans, Mr Filing and Mrs Moylan, from 22, 151 and 30 residents of Western Australia, respectively, praying that action be taken to stop the practice in China of extracting bile from caged bears for medical purposes.

Mr Aldred and Mr Beale, from 2000 and 1933 petitioners, respectively, praying for certain changes to the Family Law Act and the Child Support Scheme.

Mr Evans and Dr Kemp, from 114 and 275 petitioners, respectively, praying that the increases in petrol excise proposed in the 1993-94 Budget be opposed.

Mr Jull and Mr Lloyd, from 10 and 2 petitioners, respectively, praying that no action be taken to change the national flag unless approved by the people of Australia in a national poll.

Mr Atkinson, from 79 petitioners, praying that the cartoon "Beavis and Butthead" be banned from being shown in Australia.

Mr Atkinson, from 74 petitioners, praying that funding not be withdrawn or withheld from any child care centre where Christmas background music is played.

Mr Braithwaite, from 1911 petitioners, praying that the national flag not be changed, replaced or diminished without being voted upon and approved in a national referendum.

Mr Cameron, from 88 residents of Western Australia, praying that any attempt to dissolve the Australian Army Band, Perth, be opposed.

Mr Dodd, from 1172 electors of the Division of Leichhardt, praying that action be taken to allow the pathology centre in Gordonvale, Qld, to continue operating.

Mr Evans, from 50 petitioners, praying that the proposed scheme for the accreditation of child care centres set out in the Quality Improvement and Accreditation System Handbook be rejected.

Mr Evans, from 25 petitioners, praying that greater resources be made available for research into breast cancer.

Mr Evans, from 18 petitioners, praying that a Medicare office be opened at the Warwick Shopping Centre, WA, without delay.

Mr Evans, from 7 petitioners, praying that certain representations be made to the Government of the Socialist Republic of Vietnam concerning religious freedom and the independence of the United Vietnamese Buddhist Congregation.

Ms Fatin, from 12 parents and friends of childcare centres, praying that the linkage of accreditation to eligibility for Childcare Assistance be rejected.

Mr Fischer, from 54 petitioners, praying that no change be made to the design or colour of the Australian national flag and that it continue to represent a true manifestation of the nation's history.

Mr Forrest, from 141 residents of Victoria, praying that the ramifications of proposed legislation for child care centres be seriously considered.

Mrs Gallus, from 49 petitioners, praying that instruments affirming the United Nations Declaration on the Elimination of All Forms of Intolerance and of Discrimination Based on Religion or Belief and the United Nations Convention on the Rights of the Child be disallowed.

Mr Lloyd, from 34 petitioners, praying that the National Childcare Accreditation Council guidelines be rejected.

Mr Lloyd, from 3 petitioners, praying that Australia remain a democratic constitutional monarchy with the Queen as head of state, represented in Australia by a Governor-General.

Mr Moore, from 109 parents of Australia's children, praying that the compulsory accreditation of child care centres be opposed.

Mr Ruddock, from 44 petitioners, praying that the Government of the Socialist Republic of Vietnam be urged to release religious leaders and political prisoners, allow religious freedom and respect human and civil rights.

Mr Ruddock, from 22 petitioners, praying that the Indonesian Government be persuaded to bring a speedy end to suffering in East Timor.

Mr Ruddock, from 19 petitioners, praying that the decision to recognise Indonesia as ruler of East Timor be reversed, an appeal be made for the release of Xanana Gusmao and human rights violations in East Timor be condemned.

Mr B. C. Scott, from 89 residents of Queensland, praying that any proposal to change the Australian flag be rejected.

Mr Somlyay, from 152 electors of the Division of Fairfax, praying that the accreditation guidelines for child care centres be rejected.

Mr Truss, from 657 electors in the Division of Wide Bay, praying that transmission of the Special Broadcasting Service into the Wide Bay region, Qld, be provided as soon as possible.

Mr Tuckey, from 159 petitioners, praying that the rights of State governments alone to define and issue land title be reaffirmed through a referendum.

Mr Tuckey, from 155 petitioners, praying that the proposal to charge off-road users of diesel fuel a tax equal to one per cent of the diesel fuel rebate be abandoned.

Mr Tuckey, from 22 petitioners, praying that tax deductibility in the order of 150 per cent on approved land care expenditures be granted.

Mr Walker, from 1055 petitioners, praying that certain action be taken to lift television standards.

3 NSW BUSHFIRES

Mr Connolly, pursuant to notice, moved—That this House:

- (1) expresses its sadness at the loss of human life and damage to fauna and property caused by the recent NSW bushfires; and
- (2) commends the efforts and sacrifices of regular and volunteer firefighters from New South Wales and interstate in quelling those fires.

Debate ensued.

4 HOMELESS CHILDREN'S ALLOWANCE

Mr Braithwaite, pursuant to notice, moved—That this House:

- (1) views with concern the breakdown in Australian families, through the encouragement for children to leave those family units for the Homeless Children's Allowance; and
- (2) calls on all State government departments of family services to set down guidelines to ensure that there are appropriate and sufficient reasons before taking children from the care of their lawful parents without their knowledge.

Debate ensued.

The time allotted for the debate having expired, the debate was interrupted and the resumption of the debate made an order of the day for the next sitting Thursday.

5 CENTENARY OF THE COMMONWEALTH OF AUSTRALIA

Mr Halverson, pursuant to notice, moved—That this House:

- notes that on 1 January 2001 it will be one hundred years since the Constitution of the Commonwealth of Australia took effect and the people of Australia were united in a federal commonwealth under the name of the Commonwealth of Australia;
- (2) recognises that such a significant occasion is worthy of national observance and commemoration;
- (3) agrees that an appropriate permanent national memorial, designed by an Australian and made in Australia, should be erected in a suitable position of prominence in the national capital to mark the centenary of the Commonwealth of Australia;

- (4) suggests that such a permanent national memorial should be known as The Spirit of Australia and should represent and reflect the role and contribution of Australian men and women in the development of this great nation, so far as is possible including, but not necessarily confined to, our indigenous peoples, pioneers, explorers, scientists, defence forces, migrants, the rural community and the arts; and
- (5) calls upon the Government to organise and sponsor a competition for the design of the national memorial and that (a) such a competition carry a significant monetary prize and (b) entry to the competition be open to all Australian citizens.

Debate ensued.

Debate adjourned, and the resumption of the debate made an order of the day for the next sitting Thursday.
