Mr Keating (Prime Minister) informed the House that he had today received a letter from Mrs Kelly offering her resignation as Minister for the Environment, Sport and Territories and Minister Assisting the Prime Minister for the Status of Women and that he would be recommending to the Governor-General that the resignation be accepted.

Mr Aldred, by leave, presented the following paper:

9 PETITIONS

The Clerk announced that the following Members had each lodged petitions for presentation, viz.:

Mr Cameron and Mr Filing, from 191 and 12 residents of Western Australia, respectively, praying that action be taken to stop the practice in China of extracting bile from caged bears for medical purposes.

Mr Bradford, from 292 petitioners, praying that a Medicare office be established at the Pines Shopping Centre, Elanora, Qld, as soon as possible.

Mr Cameron, from 111 petitioners, praying that the outcome of the Mabo decision be decided by referendum.

Mr Howe, from 244 petitioners, praying that certain action be taken in response to the Human Rights and Equal Opportunity Commission's report on human rights and mental illness.

Mr Lloyd, from 64 petitioners, praying that no change be made to the design or colour of the Australian national flag and that Australia remain a democratic constitutional monarchy with the Queen as head of state, represented in Australia by a Governor-General.

Mr Lloyd, from 4 petitioners, praying that the National Childcare Accreditation Council guidelines be rejected.

Mr Peacock, from 17 petitioners, praying that proposed changes to the Australian Postal Corporation Act not be implemented so that Australia Post can continue to meet its community service obligations.

Mr Ruddock, from 284 petitioners, praying that the Government of the Socialist Republic of Vietnam be urged to release religious leaders and political prisoners, allow religious freedom and respect human and civil rights.

Mr Ruddock, from 17 petitioners, praying that action be taken to ensure the continued availability of high octane petrol to Australian motorists.

Mr Taylor, from 287 petitioners, praying that no action be taken to change the national flag unless approved by the people of Australia in a national poll.

Mr Tuckey, from 35 petitioners, praying that the rights of State governments alone to define and issue land title be reaffirmed through a referendum.

Mr Tuckey, from 20 petitioners, praying that the proposal to charge off-road users of diesel fuel a tax equal to one per cent of the diesel fuel rebate be abandoned.

Mr Tuckey, from 7 petitioners, praying that tax deductibility in the order of 150 per cent on approved land care expenditures be granted.

Mr Lee (Minister for Communications and the Arts) will represent both Ministers in this Chamber.
