2 MESSAGE FROM THE SENATE

Message No. 313, dated 23 August 1994, from the Senate was reported transmitting to the House a resolution of the Senate extending the time for the presentation of the report of the Joint Committee of Public Accounts on the proposed establishment of an Audit Committee to 22 September 1994.

3 EMPLOYMENT SERVICES BILL 1994

The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—And on the amendment moved thereto by Dr Kemp, viz.—That all words after "That" be omitted with a view to substituting the following words: "whilst not declining to give the Bill a second reading, this House deplores the Government's failure to provide real sustainable job opportunities"—

Debate resumed.

Amendment negatived.

Debate adjourned (Mr R. J. Brown), and the resumption of the debate made an order of the day for a later hour this day.

4 SUSPENSION OF STANDING AND SESSIONAL ORDERS—BILLS—REFERENCE TO COMMITTEE

Mr Snowdon (Parliamentary Secretary to the Minister for Employment, Education and Training), by leave, moved—That so much of the standing and sessional orders be suspended as would prevent the Parliamentary Secretary to the Minister for Employment, Education and Training from moving a motion to refer the Employment Services Bill 1994 together with the amendments, new headings and new clauses to be moved on behalf of the Government and the Employment Services (Consequential Amendments) Bill 1994 together with the amendments and new clauses to be moved on behalf of the Government to the Standing Committee on Legal and Constitutional Affairs for consideration and an advisory report. Debate ensued.

Question—put and passed.

5 BILLS—REFERENCE TO COMMITTEE

Mr Snowdon (Parliamentary Secretary to the Minister for Employment, Education and Training) moved—That:

- (1) the Employment Services Bill 1994 together with the amendments, new headings and new clauses to be moved on behalf of the Government and the Employment Services (Consequential Amendments) Bill 1994 together with the amendments and new clauses to be moved on behalf of the Government be referred to the Standing Committee on Legal and Constitutional Affairs for consideration and an advisory report; and
- (2) the Committee present its report to the House by 22 September 1994.

Question—put and passed.

6 STATES GRANTS (GENERAL PURPOSES) BILL 1994

The order of the day having been read for the second reading—Mr Gear (Assistant Treasurer) moved—That the Bill be now read a second time.

Mr Costello moved, as an amendment—That all words after "That" be omitted with a view to substituting the following words: "whilst not declining to give the Bill a second reading, the House condemns the Government for:

- (1) its continuing mismanagement of Commonwealth-State relations; and
- (2) its threat to recoup from any State funds paid to that State as a result of the Parliament of that State repealing laws which prescribe compulsory student unionism at universities".

Debate continued.

9 HUMAN RIGHTS AND EQUAL OPPORTUNITY COMMISSION--REPORT ON THE SITUATION OF AUSTRALIAN SOUTH SEA ISLANDERS-GOVERNMENT RESPONSE-MINISTERIAL STATEMENT AND PAPER-MOTION TO TAKE NOTE OF PAPER

Mr Lavarch (Attorney-General), by leave, made a ministerial statement in connection with the Government's response to the report of the Human Rights and Equal Opportunity Commission on the situation of Australian South Sea Islanders, and presented the following paper:

Human Rights and Equal Opportunity Commission Act—Human Rights and Equal Opportunity Commission—Report—The call for recognition: A report on the situation of Australian South Sea Islanders—Government response, August 1994.

Mr Neville and Mr Nehl, by leave, also made statements concerning the matter.

10 DISCUSSION OF MATTER OF PUBLIC IMPORTANCE—"THREE MINES" URANIUM POLICY

The House was informed that Mr McGauran had proposed that a definite matter of public importance be submitted to the House for discussion, namely, "The failure of the Government to abolish its discredited 'three mines' uranium policy, which has cost Australia hundreds of millions of dollars of export income and new investment".

11 ENVIRONMENT, SPORT AND TERRITORIES LEGISLATION AMENDMENT BILL 1994—REPORT FROM MAIN COMMITTEE

The Deputy Speaker reported that the Environment, Sport and Territories Legislation Amendment Bill 1994 had been fully considered in the Main Committee and agreed to without amendment, and presented a certified copy of the Bill.

Bill agreed to.

On the motion of Mr Beddall (Minister for Resources), by leave, the Bill was read a third time.

12 AUSTRALIAN PARLIAMENTARY DELEGATION—REPORT—REPORT FROM MAIN COMMITTEE—PAPER NOTED

The Deputy Speaker reported that the order of the day relating to the motion to take note of the report of the Australian Parliamentary Delegation to Bougainville had been debated in the Main Committee and is returned to the House.

Question—That the House take note of the paper—put and passed.

13 BILLS—REPORT FROM MAIN COMMITTEE

The Deputy Speaker reported that the Main Committee had not considered the Grain Legumes Levy Amendment Bill 1994, the Oilseeds Levy Amendment Bill 1994, the Coarse Grains Levy Amendment Bill 1994, the Vocational Education and Training Funding Amendment Bill 1994, the Evidence Bill 1993 and the

Evidence (Transitional Provisions and Consequential Amendments) Bill 1994 and returned the Bills to the House for consideration, and presented certified copies of each of the Bills.

Ordered—That, in accordance with the resolution agreed to on 23 August 1994, consideration of each of the Bills be made an order of the day for a later hour this day.
