3 TELECOMMUNICATIONS (STANDARDS OF SERVICE) AMENDMENT BILL 1994

Mr Forrest, pursuant to notice, presented a Bill for an Act to amend the *Telecommunications Act 1991* and other legislation in respect of standards of service.

Mr Forrest made a statement in relation to the Bill.

Bill read a first time.

Ordered—That the second reading be made an order of the day for the next sitting Monday, in accordance with standing order 104A.

4 MRS HARRY (LORES) BONNEY

Mrs Sullivan, pursuant to notice, moved—That this House:

- acknowledges the pre-eminent pioneering role played by the late Mrs Harry (Lores) Bonney in the development of Australian and international aviation; and
- (2) urges all Australian governments and relevant semi-government bodies to ensure that Mrs Bonney's contribution to the nation receive appropriate, continuing public recognition.

Debate ensued.

5 COMMITTEE OF PRIVILEGES

Mr Price, pursuant to notice, moved-

- (1) That the following amendment to standing order 26 (Committee of Privileges) be adopted for the remainder of this session: Omit "to inquire into and report upon complaints of breach of privilege which may be referred to it" and substitute "to inquire into and report upon matters of contempt or breach of privilege which may be referred to it".
- (2) That the following matter be referred to the Committee of Privileges: The question of the level of protection or privilege which should apply to communications between Members of Parliament and Ministers, including communications by letter, facsimile or other electronic or automated means.

Debate ensued.

The time allotted for the debate having expired, the debate was interrupted and the resumption of the debate made an order of the day for the next sitting Monday.

6 MUNICIPAL LIBRARIES

The order of the day having been read for the resumption of the debate on the motion of Mr Latham—That this House declares its support for:

- (1) federal funding of municipal libraries to promote quality, equity and access to those services in areas of greatest need; and
- (2) developing Australia's network of 1400 municipal libraries as public access points on the so-called information superhighway—

7 ECOTERRORISM

As a mark of respect to the memory of the deceased all Members present stood, in silence.

10 DEATH OF DR P. S. WILENSKI

The Speaker informed the House of the death, on 3 November 1994, of Dr Peter Stephen Wilenski, AC.

Mr Forrest, from 1614 petitioners, praying that certain action be taken to improve the financial position of citrus growers.

Mr Langmore, from 155 petitioners, praying that logging in the Deua wilderness and other forest areas of high conservation value in New South Wales be stopped.

Mr McLeay, from 956 petitioners, praying that certain action be taken to resolve the Turkish occupation of Cyprus.

Mr Moore, from 92 petitioners, praying that the guidelines for homeless rate recipients be reviewed and greater commitment shown to programs which prevent family breakdown.

Mr Neville, from 231 petitioners, praying that discrimination against single-income families in the tax and social security systems be removed.

Mr Neville, from 30 petitioners, praying that certain action be taken to create jobs in State forests.

Mr B. C. Scott, from 60 electors of the Division of Maranoa, praying that the national flag not be changed, replaced or diminished without being voted upon and approved in a national referendum.

Mr Sinclair, from 33 petitioners, praying that inequities faced by rural students in the higher education system be addressed.

Mr S. F. Smith, from 338 petitioners, praying that Mr Li Shi Ping and Miss Liu Xiu Ling be granted refugee status and released from custody.

Mr Wakelin, from 76 petitioners, praying that Austudy and Abstudy payments be increased to levels comparable to social security benefits.

- (1) its inability to solve the unemployment crisis;
- (2) the continued failure to provide adequate assistance to low income families;
- (3) its harsh treatment of older single women with limited employment experience, including the abolition of the widow B pension;
- (4) financially disadvantaging groups of unemployed low income earners by way of changes to the job search/newstart allowance income tests;
- (5) the public confusion created by the introduction of the home child care allowance regime, and the subsequent confusion which will result from the parenting allowance, partner allowance and wife pension changes; and
- (6) its failure to provide additional home child care support to low income families, principally the unemployed".
