6 THE SUNKEN HMAS SYDNEY

Mr Filing, pursuant to notice, moved—That this House calls on the Government to:

- (1) consider supporting any move to locate the sunken vessel HMAS Sydney;
- (2) accept that, regardless of the outcome, surviving family members of those who lost their lives on HMAS *Sydney* are owed consideration of a full-scale public search for the vessel;
- (3) support public efforts to raise money to assist in locating the wreck;
- (4) fund and coordinate a suitable commemorative service for those who lost their lives on HMAS *Sydney* should the vessel be located;
- (5) erect a suitable memorial in Canberra to commemorate the loss of HMAS *Sydney* in accordance with the wishes of surviving family members;
- (6) ensure the exact coordinates of the sunken HMAS *Sydney* are not disclosed to the general public;
- (7) establish an Act of Parliament which protects the wreck from being dived upon other than for purposes of official identification and provide substantial penalties for transgressions of the Act; and

(8) once the Act is established, embark on an extensive advertising campaign to make the public aware that diving on HMAS *Sydney* is a criminal offence and the penalties applicable.

Debate ensued.

Mr Beale, from 36 petitioners, praying for certain changes to the Family Law Act and the Child Support Scheme.

Mr Beale, from 23 petitioners, praying that no change be made to the national flag without a full referendum.

Mr Cadman, from 40 petitioners, praying that the House call on the Minister for Human Services and Health to withdraw her endorsement of the sex guide published in the December 1994 issue of *Cleo* magazine and on the Prime Minister to indicate his disapproval of it.

Mr Somlyay, from 10 electors of the Division of Fairfax, in similar terms.

Mr Dodd, from 180 petitioners, praying that certain action be taken to ensure the equitable provision of undergraduate and postgraduate education.

Mrs Easson, from 401 residents of Dobroyd Point, NSW, praying that the application for year round funding by the Dobroyd Point Outside of School Hours Centre be reconsidered.

Mr Kerr, from 16 residents of Tasmania, praying that funding for the Alternative Birthing Service be continued.

Mr Mack, from 1077 petitioners, praying for a moratorium on logging and woodchipping in all forests of high conservation value in New South Wales until an adequate reserve system is developed.

Mr Mack, from 233 petitioners, praying that woodchipping be phased out and certain other action be taken in relation to the forests of south eastern Australia.

Mr Mack, from 38 petitioners, praying that certain actions be taken to protect all native old growth, wilderness and other high conservation value forests in Australia.

Mr Slipper, from 1393 electors of the Division of Fisher, praying that an application to establish a pharmacy in the shopping centre at Ningi, Qld, be granted.

Mr Taylor, from 151 petitioners, praying that funding for breast cancer research be increased tenfold in the Budget and initiatives to encourage donations for research be considered.

Mr Taylor, from 88 petitioners, praying that sections of the Social Security Act which treat unrealised capital gains on shares as income under the social security income test for pensioners be repealed.

Mr Taylor, from 64 petitioners, praying that the Australian National Flag not be changed without approval through a national poll.

Mr Truss, from 29 petitioners, praying that the current national flag be preserved and no change be made to its design unless supported by referendum by the majority of Australians in the majority of States.

Mr Wakelin, from 614 petitioners, praying that the sales tax on wine not be increased nor excise imposed.

Mr Wakelin, from 610 residents of regional South Australia, praying that funding be made available for the expansion of the Triple J radio network to regional South Australia.
