the Bill and whilst recognising that this Bill provides some improvement to the unfair dismissal provisions of the Industrial Relations Act, the House is of the opinion that, even as amended, the unfair dismissal provisions of the Industrial Relations Act remain a disincentive to job creation, that they impose a very heavy burden on business, particularly on small business, and that they were enacted without proper prior consultation"—
