Mr Albanese made a statement in relation to the Bill.

*Paper:* Mr Albanese, by leave, presented an explanatory memorandum to the Bill.

Bill read a first time.

Ordered—That the second reading be made an order of the day for the next sitting, in accordance with standing order 104A.

# 4 PLEDGE OF COMMITMENT AS A CITIZEN OF THE COMMONWEALTH OF AUSTRALIA

Ms Hanson, pursuant to notice, moved—That this House calls on the Government to strengthen the pledge of commitment as a citizen of the Commonwealth of Australia into a pledge of loyalty to acknowledge the primacy of the interests of Australia and its people above all others.

Debate ensued.

At 1.45 p.m., the time allotted for the debate having expired, the debate was interrupted in accordance with standing order 106A, Mr R. A. Cameron was granted leave to continue his speech when the debate is resumed and the resumption of the debate was made an order of the day for the next sitting.

Mr Albanese, from 184 petitioners, praying that the Marrickville, NSW, Medicare Office remain open.

Mr Anthony, from 48 electors of the Division of Richmond, praying that the operational subsidy remain for community based child care centres and certain other action be taken in relation to child care.

Mr Bradford, from 59 residents of Queensland, Ms Macklin, from 32 parents and staff of a long day care community children's centre, Ms Macklin, from 11 033 residents of the Australian Capital Territory, Queensland, South Australia, Tasmania and Victoria, respectively, in similar terms.

Mr Bevis, from 120 residents of Queensland, praying that the decision to cut funding to the ABC be rescinded.

Mr Bevis, from 53 residents of Queensland, praying that reforms to public housing assistance be delayed to ensure effective transitional arrangements.

Mr Bradford, from 282 electors of the Division of McPherson, praying that offices of the Commonwealth Employment Service and the Department of Social Security in Palm Beach, Qld, be relocated.

Mrs Crosio, from 20 petitioners, praying that operational subsidies to community based long day child care centres be retained.

Mr McClelland, from 53 residents of Sydney, praying that the decision to remove the ability of permanent residents to sponsor the migration of family members be revoked.

Mr McClelland, from 52 residents of Sydney, praying that the decision to increase fees for certain family visa classes be revoked.

Mr McClelland, from 51 residents of Sydney, praying that the decision to impose a cap on certain family visa classes be revoked.

Mr McClelland, from 36 residents of New South Wales, praying that the outcomes of the 1996 Budget in relation to child care be reversed and certain other action be taken in relation to child care.

Mr McClelland, from 35 residents of New South Wales, praying that funding to Department of Employment, Education, Training and Youth Affairs English language classes be restored and the limit imposed on Department of Immigration and Multicultural Affairs funded English language classes be abolished.

Mr McClelland, from 15 residents of Sydney, in similar terms.

Mr Melham, from 7545 petitioners, praying that Holsworthy be opposed as a site for Sydney's second international airport.

Mr Melham, from 5110 petitioners, in similar terms.

Mr Melham, from 9 petitioners, praying that the current level of funding to the ABC be maintained.

Mr Miles, from 217 students, teachers and parents of students of Tasmania, praying that legislation that will increase fees under the Higher Education Contribution Scheme be rejected.

Mr Moore, from 947 petitioners, praying that legislation be passed to prevent euthanasia and certain other action be taken in relation to the issue of euthanasia.

Mr Nairn, from 5 residents of New South Wales and the Australian Capital Territory, praying that assistance be provided to the Munjuwa Queanbeyan Aboriginal Corporation to obtain alternative funding.

Mr Scott, from 57 petitioners, praying that the exclusiveness of marriage as being between one male and one female be preserved and that the Marriage Act be amended to prohibit certain marriages.

Mr Tanner, from 10 residents of Queensland, praying that legislation that would impact upon existing quality, affordable child care not be passed. Petitions received.

# 9 SECOND INTERNATIONAL AIRPORT FOR SYDNEY

Mrs Crosio, pursuant to notice, moved—That the House:

- notes the high level of community concern in the Greater Western Sydney region over the proposed construction of a second international airport at Badgerys Creek;
- (2) acknowledges that the Sydney basin has a finite population capacity and it is clearly approaching its limits for absorbing air and water pollution;
- (3) recognises that building a second international airport, either at Badgerys Creek or Holsworthy, inside the Sydney basin will subject hundreds of thousands of people to the same, if not worse, environmental and lifestyle problems which have already beset the residents surrounding Sydney (Kingsford-Smith) Airport;
- (4) calls on the Minister for Transport and Regional Development to initiate an Environmental Impact Study on Goulburn as a site for an international airport, to run in conjunction with the current studies on the Holsworthy and Badgerys Creek airport sites;
- (5) calls on the Minister for Transport and Regional Development to commission a study into the economic and social benefits for the Southern Highlands region in building an international airport at Goulburn serviced by a "very fast train" of the kind currently in operation, or being considered for operation, in Europe; and
- (6) conducts an inquiry through the relevant parliamentary standing committee into the viability of, and the benefits associated with, the operation of a "very fast train" linking Sydney and Canberra, and its capacity to act as the main conduit for passengers and freight between Sydney and an international airport situated at Goulburn.

# 10 **IRAQ**

Mr Somlyay, pursuant to notice, moved-That this House:

- (1) condemns the Government of Iraq and particularly President Saddam Hussein for his continued, constant and unwarranted aggression against the Kuwaiti people and their government;
- (2) condemns the flagrant violations of human rights by the Government of Iraq in continuing to illegally hold hundreds of Kuwaiti citizens as prisoners of war since its abortive invasion of Kuwait in 1990; and
- (3) urges the international community, through its representatives at the UN, to:
  - (a) increase their efforts to achieve a lasting solution to the aggression of Iraq against its neighbours; and
  - (b) ensure the safe and speedy return of all prisoners of war held by the Government of Iraq.

Debate ensued.

Debate adjourned, and the resumption of the debate made an order of the day for the next sitting.

# 15 CHILD CARE LEGISLATION AMENDMENT BILL 1996

- (2) condemns the Government for breaking its election promise not to means test the Childcare Cash Rebate"—
