10 PETITIONS

The Clerk announced that the following Members had each lodged petitions for presentation, viz.:

Mr Fitzgibbon, from 66 families and friends of Kurri Early Childhood Centre Inc., NSW; Mr Lloyd, from 71 families and friends of Woy Woy Peninsular Community Childcare Centre, NSW and Mr Price, from 59 families and friends of Margaret Druitt Day Care Centre, NSW, respectively, praying that operational subsidies to community based long day care centres be retained.

Mr Fitzgibbon, Mr A. A. Morris and Mr Ruddock, from 180, 1424 and 10 residents of New South Wales, respectively, praying that the practice of issuing provider numbers only to certain medical practitioners be opposed.

Mr Lee, from 20 friends of the ABC, and Mr Lee, from 14 petitioners, respectively, praying that the current level of funding to the ABC be maintained.

Mr P. J. Baldwin, from 852 petitioners, praying that proposed changes to the Commonwealth-State Housing Agreement be opposed.

Mr Cadman, from 56 petitioners, praying that certain action be taken to promote the recognition of human rights in Sudan.

Mr Causley, from 2202 citizens and business proprietors of the Northern Rivers Region, NSW, praying that the Copyright Act be amended to exclude business from the requirement to hold copyright music licences for the playing of background music.

Mr Causley, from 15 residents of the Northern Rivers Region, NSW, praying that funding to the ABC not be decreased and advertising not be introduced.

Mr Dondas, from 228 petitioners, praying that certain action be taken to reduce the tax on fuel.

Mr Dondas, from 183 residents of the Northern Territory, praying that the operational subsidy to community based child care centres be maintained.

Mr Holding, from 97 residents of Victoria, praying that funding cuts to the ABC be reversed.

Mr Jones, from 41 residents of Victoria, praying that the outcomes of the 1996 Budget in relation to child care be reversed and certain other action be taken in relation to child care.

Mr Lee, from 86 petitioners, praying that the proposed removal of operational assistance from Family Day Care not be endorsed.

Mr Lee, from 18 petitioners, in similar terms.

Mr Lee, from 21 petitioners, praying that ABC services' funding arrangements be retained and that its services be free of commercial sponsorship and advertising. Mr Marek, from 38 petitioners, praying that the weekly pension be increased by ten dollars above the Consumer Price Index.

Mr Ronaldson, from 1085 residents of Victoria, praying that the decision to terminate the book bounty be reversed.

Mr Williams, from 5190 petitioners, praying that the national gun law measures be supported and expedited.

Mr Williams, from 495 petitioners, praying that certain moves to tighten gun laws be supported.

12 BURMA-THAILAND RAILWAY-PRISONER OF WAR MEMORIAL

- (2) commends the Government on its initiative to construct a museum and memorial to prisoners of war near Hellfire Pass in Thailand;
- (3) commends Mr Rod Beattie and his associates for their work in clearing a 4km walking trail along the Burma-Thailand railway at Hellfire Pass; and
- (4) calls on Australian companies, ex-service organisations and other countries whose service personnel also worked on the railway to support the Prisoner of War Memorial project.

18 TAXATION LAWS AMENDMENT BILL (NO. 3) 1996

The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—

Debate resumed by Mr Latham who moved, as an amendment—That all words after "That" be omitted with a view to substituting the following words: "whilst not declining to give the Bill a second reading, the House is of the opinion that:

- (1) the Government has substantially increased the tax burden on ordinary PAYE taxpayers;
- (2) the Government's tax and transfer policies substantially disadvantage women who choose to have both a family and paid work;
- (3) the Bill will substantially reduce industry research and development in Australia, thereby eroding our competitive advantages, economic growth and employment creation;
- (4) the Bill will damage co-operative companies and especially damage employment, investment and local ownership in regional Australia at a time when the Government has flattened growth and economic activity; and
- (5) the Bill further erodes the universal health safety net provisions associated with Medicare and further leads to the creation of a two tier health system in Australia".
