### 5 CHILD SUPPORT (ASSESSMENT) AMENDMENT BILL 1997

Mr Price, pursuant to notice, presented a Bill for an Act to amend the *Child Support (Assessment) Act 1989*.

Mr Price made a statement in relation to the Bill.

Bill read a first time.

Ordered—That the second reading be made an order of the day for the next sitting, in accordance with standing order 104A.

#### 6 RELIGIOUS FREEDOM OF THE BAHA'IS IN IRAN

Mr L. D. T. Ferguson, pursuant to notice, moved—That this House:

- (1) strongly condemns the death sentences for apostasy imposed by the Iranian courts on Mr Musa Talibi and Mr Dhabihu'llah Mahrami, two members of the Baha'i Faith, particularly noting the gross violation of freedom of religion these sentences involve in contravention of the Universal Declaration of Human Rights and the International Covenant on Civil and Political Rights, to which Iran is a party;
- (2) strongly condemns the imposition of death sentences against two other Baha'is, Mr Kayvan Khalajabadi and Mr Bihnam Mithaqi, held by the Iranian authorities, again for reasons arising from their religious beliefs;
- (3) calls for the immediate revocation of all such death sentences and the immediate release of the individuals involved;
- (4) deplores the continuing practice in Iran of short and long term detention of Baha'is for their religious beliefs and other grave breaches of human

rights against the Baha'is in Iran, including the banning of the sacred institutions of the Baha'i community and the criminalisation of membership of these institutions, denial of education and employment of individual Baha'is, the continuing failure to remedy the confiscation and destruction of holy places and community and personal property of Baha'is, continuing restrictions on freedom of movement and the right of assembly, and discrimination by the judiciary;

- (5) calls on the Government of Iran to ensure that no more Baha'is are subjected to sentences of death or imprisoned for their religious beliefs and that all current sentences of this nature against Baha'is are revoked and the individuals involved immediately released;
- (6) notes with concern Iran's failure to respond to the recommendations of Mr Abdelfattah Amor, UN Special Rapporteur for Religious Intolerance, regarding the violation of religious freedom in Iran, and urges the Government of Iran to take immediate steps to implement all those recommendations, particularly as they relate to Baha'is and protestant religious minorities;
- (7) notes also with concern the continuation generally of violations of human rights in Iran, including the high number of executions in the absence of internationally recognised safeguards, cases of torture and cruel, inhuman or degrading treatment or punishment, the failure to meet international standards with regard to the administration of justice and the absence of due process of law, violations of the right to peaceful assembly and restrictions on the freedom of expression, thought, opinion and the press and calls on the Government of Iran to ensure full respect for human rights within its borders; and
- (8) commends successive Australian governments for Australia's long standing and continuing support of religious freedom of the Baha'is in Iran, particularly in UN forums, and urges that further bilateral and multilateral diplomatic measures be taken in support of religious freedoms of the Baha'is and religious freedom generally.

Debate ensued.

Debate adjourned, and the resumption of the debate made an order of the day for the next sitting.

Mr Latham and Mr McClelland, from 28 and 2555 residents of Sydney, Mr P F Morris, from 44 electors of the Division of Shortland, and Mr Price, from 476 residents of western Sydney, respectively, praying that the proposal to introduce nursing home entry fees be abandoned and full funding for capital assistance to nursing homes be restored.

Mr Andren, from 19 owners of freehold and leasehold land, praying that legislation be passed to ensure that granting pastoral leases and freehold land automatically extinguishes native title.

Mr Beazley, from 198 electors of the Division of Lilley, praying that legislation which will cause the Golden Circle Fruit and Vegetable Cannery at Northgate, Qld, to relocate offshore be reconsidered.

Mr L. D. T. Ferguson, from 180 residents of New South Wales, praying that nursing home care be available to all and that the family home be exempted from asset tests relating to payment for such care.

Mr Griffin, from 48 residents of Victoria, praying that funding cuts to the Home and Community Care Program be reversed.

Mr Griffin, from 21 residents of Victoria, praying that full funding to Ausmusic be reinstated.

Mr Hawker, from 39 petitioners, praying that better mobile phone services be installed in western Victoria.

Mr Latham, from 1265 residents of Campbelltown and Liverpool, NSW, praying that any plan to construct an airport at Holsworthy, NSW, be abandoned.

Mr Marek, from 104 petitioners, praying that certain reforms to the Child Support Scheme be implemented.

Mr P. F. Morris, from 200 electors of the Division of Shortland, praying that the Belmont, NSW, Medicare Office remain open.

Mr Mossfield, from 137 residents of New South Wales, praying that the importation of cooked chicken meat products not be permitted.

Mr Mossfield, from 10 petitioners, praying that a high profile anti-racism campaign be mounted.

Mrs Moylan, from 173 residents of Roleystone, WA, praying that the rights of citizens who may be adversely affected by the erection of any proposed telecommunication tower be protected.

Mr Pyne, from 64 employees of Cutler Brands Pty Ltd, praying that tariffs be frozen at current levels.

Mrs D. S. Vale, from 208 residents of New South Wales, praying that Holsworthy be opposed as a site for Sydney's second international airport.

Mrs D. S. Vale, from 25 petitioners, praying that the importation of animals for exhibition in circuses be prohibited.

#### 12 HEROIN TRADE IN SOUTH WEST SYDNEY

Mrs Crosio, pursuant to notice, moved—That this House recognises:

- (1) the grave extent of the heroin trade in south west Sydney and the shocking availability of the drug for purchase, especially on the streets of Cabramatta and Fairfield:
- (2) the disastrous social problems currently being caused by the heroin trade in south west Sydney;
- (3) that many of the dealers and addicts involved in the heroin trade in south west Sydney are teenagers, with some users as young as 11 and 12, and are having their lives ruined as a result;
- (4) that the reckless discarding of used syringes in an improper manner is causing great distress and threatening the health of many families and small business people in south west Sydney; and
- (5) that the trade and use of heroin in south western Sydney is moving rapidly from bad to worse and that government, at all levels, must look for better and more effective ways of combating what has become one of Australia's most serious social problems.

#### 19 MESSAGE FROM THE SENATE—AUTOMOTIVE INDUSTRY

The following message from the Senate was reported:

Message No. 245

Mr Speaker

The Senate again transmits to the House of Representatives the following resolution which was agreed to by the Senate on 28 May 1997:

That, in the opinion of the Senate, the following is a matter of urgency:

The need to secure the future of the Australian automotive industry and create an environment which supports a doubling of motor vehicle exports to 100,000 units per year, a trebling of components exports to \$3 billion and up to 10,000 new jobs, by establishing a post-2000 assistance regime which:

- (a) ensures that tariffs on motor vehicles, original equipment and replacement components should not fall below 15% at least until 2005 (while maintaining our commitments under APEC);
- (b) establishes a transparent measure by which the progress of our trading partners in reducing their tariff and non-tariff barriers can be judged;
- (c) reviews the industry's position in 2003 to determine the assistance needed beyond 2005 (in formulating its recommendations, the review to have regard to the progress of our trading partners in reducing

barriers to trade and the impact of any policy changes on regional Australia);

- (d) ensures that the Export Facilitation Scheme is not removed without putting in place a program of equivalent value, consistent with our World Trade Organization obligations;
- (e) continues the duty-free allowance to support domestic market valueadded; and
- (f) provides measures which ensure a more supportive industrial research and development environment.

The Senate requests the concurrence of the House in this resolution.

- (5) continues the duty-free allowance to support domestic market value-added; and
- (6) provides measures which ensure a more supportive industrial research and development environment".

- (1) the fact that any changes to the tariff regime will require legislation, and there is widespread concern that, as with the zero sugar tariff issue, the relevant legislation will be delayed;
- (2) the fact that there are clear divisions within the Government on this matter, most recently made obvious in the House today by the Member for Kingston backing a tariff freeze;
- (3) the fact that many thousands of jobs depend on the automotive industry;
- (4) the fact that the automotive industry committed itself to increase jobs and exports based on the implementation of Labor's plan;
- (5) the fact that the Prime Minister has called on backbenchers to make their views known;

The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—And on the amendment moved thereto by Mr G. J. Evans (Deputy Leader of the Opposition), viz.—That all words after "That" be omitted with a view to substituting the following words: "whilst not declining to give the Bill a second reading, the House notes that the Budget:

- (1) does nothing for jobs—the nation's most overwhelming current economic and social problem;
- (2) squanders, by breaking the promise to introduce superannuation cocontributions, an historic opportunity to build a massive new private

savings pool, and does so in a way that undercuts decent retirement incomes for lower and middle income earners;

- (3) continues the assault on families, the elderly and the needy;
- (4) contains many mindless and counter-productive cuts affecting the quality and decency of life in Australia, and harming our international reputation;
- (5) for all its cuts and destructive impact, did not meet the exaggerated expectations the Government had created as to the size of its deficit reduction achievements and projected future surpluses; and
- (6) has been characterised by even the Government's best friends as lacking in shape, direction and vision"—
