2 WOOL SERVICES PRIVATISATION BILL 2000

The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—

Debate resumed.

Question—put and passed—Bill read a second time.

Message from the Governor-General

Message No. 249, 4 September 2000, from His Excellency the Governor-General was announced recommending an appropriation for the purposes of the Bill.

Leave granted for third reading to be moved forthwith.

On the motion of Mr Truss (Minister for Agriculture, Fisheries and Forestry), the Bill was read a third time.

3 AUSTRALIAN RESEARCH COUNCIL BILL 2000

The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—

Debate resumed by Mr Lee who moved, as an amendment—That all words after "That" be omitted with a view to substituting the following words:

"whilst not declining to give the bill a second reading, the House condemns the Government for:

- (1) cutting Commonwealth Government investment in higher education by a billion dollars;
- (2) proposing new arrangements for higher education research which:
 - (a) reduce the number of Commonwealth-funded research training places, particularly hurting newer, smaller and regional universities; and
 - (b) fail to address the need for increased research funding;

- (3) abolishing the National Board of Employment, Education and Training and thereby removing a significant source of corporate knowledge and independent advice; and
- (4) seeking to reduce the independence of the Australian Research Council, by removing its ability to initiate advice".

Debate continued.

It being 2 p.m., the debate was interrupted in accordance with standing order 101A, and the resumption of the debate made an order of the day for a later hour this day.
