Bill read a first time.

Mr McGauran moved—That the Bill be now read a second time.

#### 5 EXCISE TARIFF AMENDMENT (CRUDE OIL) BILL 2001

Mr Entsch (Parliamentary Secretary to the Minister for Industry, Science and Resources) presented a Bill for an Act to amend the *Excise Tariff Act 1921*, and for related purposes.

Bill read a first time.

Mr Entsch moved-That the Bill be now read a second time.

# 6 JURISDICTION OF THE FEDERAL MAGISTRATES SERVICE LEGISLATION AMENDMENT BILL 2001

Mr Slipper (Parliamentary Secretary to the Minister for Finance and Administration), for Mr Williams (Attorney-General), pursuant to notice, presented a Bill for an Act to amend the law relating to the jurisdiction of the Federal Magistrates Service, and for related purposes.

Bill read a first time.

Mr Slipper moved—That the Bill be now read a second time.

Mr Slipper presented an explanatory memorandum to the Bill.

Debate adjourned (Mr Griffin), and the resumption of the debate made an order of the day for the next sitting.

Question—put and passed—Bill read a second time.

Leave granted for third reading to be moved forthwith.

On the motion of Mr Abbott (Minister for Employment, Workplace Relations and Small Business), the Bill was read a third time.

# 9 TAXATION LAWS AMENDMENT BILL (NO. 6) 2001

Mr Slipper (Parliamentary Secretary to the Minister for Finance and Administration) presented a Bill for an Act to amend the law relating to taxation.

Bill read a first time.

Mr Slipper moved—That the Bill be now read a second time.

Paper

Mr Slipper presented an explanatory memorandum to the Bill.

Debate adjourned (Mr Smith), and the resumption of the debate made an order of the day for the next sitting.

# 10 TRADE PRACTICES AMENDMENT (TELECOMMUNICATIONS) BILL 2001

The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—

Debate resumed by Mr Smith who moved, as an amendment—That all words after "That" be omitted with a view to substituting the following words:

"whilst not declining to give the bill a second reading, the House:

- (1) notes the lack of effective competition in significant parts of the Australian telecommunications industry;
- (2) notes the Government's failure to respond in a timely manner to widespread industry concerns held since at least January 1999 about delays in the telecommunications competition regime, which continue to the detriment of both consumers and the industry;
- (3) notes that the cause of the Government's failure to act has been its ideological obsession with the full privatisation of Telstra; and
- (4) calls on the Government to urgently consider further reform as part of its response to the final report of the Productivity Commission's inquiry into the telecommunications competition regime due next month".

Debate continued.

Amendment negatived.

Question—That the Bill be now read a second time—put and passed—Bill read a second time.

Leave granted for third reading to be moved forthwith.

On the motion of Dr Nelson (Parliamentary Secretary to the Minister for Defence), the Bill was read a third time.

# 11 BANKRUPTCY LEGISLATION AMENDMENT BILL 2001

The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—

Debate resumed by Mr McClelland who moved, as an amendment—That all words after "That" be omitted with a view to substituting the following words: "whilst not declining to give the Bill a second reading, the House:

- (1) condemns the government for introducing a tax system that has caused a significant increase in the number of bankruptcies;
- (2) condemns the government for failing to prevent the excesses of some sections of corporate Australia but scapegoating those ordinary citizens and unincorporated small businesses who are unable to pay their debts by virtue of the GST;
- (3) condemns the government for failing to act to stop tax avoidance by virtue of the improper use of the bankruptcy laws; and
- (4) calls on the government to act to stamp out illegal tax avoidance in all its forms".

Debate continued.

It being 2 p.m., the debate was interrupted in accordance with standing order 101A, and the resumption of the debate made an order of the day for a later hour this day.

#### 13 DISCUSSION OF MATTER OF PUBLIC IMPORTANCE-MV TAMPA

The House was informed that Mr Beazley (Leader of the Opposition) had proposed that a definite matter of public importance be submitted to the House for discussion, namely, "The failure of the Government to put in place a comprehensive solution to the situation of the people on board the MV *Tampa*".

The proposed discussion having received the necessary support-

Mr Beazley addressed the House.

Discussion ensued.

Discussion concluded.

# 14 LEAVE OF ABSENCE TO MEMBER

Mr Slipper (Parliamentary Secretary to the Minister for Finance and Administration) moved—That leave of absence for the remainder of the period of sittings be given to Mr Lieberman on the ground of parliamentary business overseas.

Debate ensued.

Question—put and passed.

#### 15 ENVIRONMENTAL LEGISLATION AMENDMENT BILL (NO. 2) 2001—REPORT FROM MAIN COMMITTEE

The Speaker reported that the Bill had been fully considered by the Main Committee and agreed to without amendment, and presented a certified copy of the Bill.

Bill agreed to.

On the motion of Mr Slipper (Parliamentary Secretary to the Minister for Finance and Administration), by leave, the Bill was read a third time.

# 16 PARLIAMENTARY SERVICE AMENDMENT BILL 2001—REPORT FROM MAIN COMMITTEE

- (5) acknowledges that this is an alliance between two peoples forever committed to democracy, and its foundation stones of freedom of speech, freedom of the press, and the independence and authority of the rule of law; and
- (6) affirms its belief that the alliance will continue playing a vital role in a changing world, building a prosperous and secure future for our two nations, the Asia-Pacific region and the global community.

Debate ensued.

# 29 AUSTRALIAN NATIONAL FLAG

Mr Anderson (Deputy Prime Minister), for Mr Howard (Prime Minister), pursuant to notice, moved—That this House:

- (1) recognises and celebrates the centenary of the Australian National Flag which occurs on 3 September this year;
- (2) honours the ideals for which our national flag stands including our history, geography and unity as a federated nation;
- (3) notes that this is the world's only national flag ever to fly over one entire continent;
- (4) acknowledges that our flag has been Australia's pre-eminent national symbol in times of adversity and war, peacetime and prosperity;
- (5) recognises that our flag now belongs to the Australian people and has been an integral part of the expression of our national pride; and
- (6) expresses its respect for the Australian National Flag as a symbol of our profound achievements as a federation; our independence and freedom as a people; and our optimism for a common future together.
