### TUESDAY, 13TH SEPTEMBER, 1910.

- 1. The House met pursuant to adjournment .-- Mr. Speaker took the Chair, and read Prayers.
- PETITION.—Mr. Glynn presented a Petition from about 240 Taxpayers in South Australia praying that the House will reject the Land Tax Assessment Bill. Petition received.
- 3. CONSTITUTION ALTERATION (UNIFICATION) BILL.—Mr. Bamford, pursuant to leave given on 18th August last, brought up a Bill intituled "A Bill for an Act to alter the provisions of the Constitution so as to provide for the Reconstruction of the States of the Commonwealth", and moved, That it be now read a first time.

Question-put and passed.-Bill read a first time.

Ordered-That the second reading be made an Order of the Day for Thursday, 20th October next.

4. PAPERS .-- Mr. O'Malley presented, by command of His Excellency the Governor-General-

- Federal Capital Territory (Yass Canberra Site)—Water Supply and Rainfall—Record of discharges at the official weir on the Cotter River from the date of the establishment of the gauge (20th May, 1910) to 7th September, 1910, and Memorandum by the Commonwealth Meteorologist on the Average Rainfall.
- Ordered to lie on the Table, and to be printed.
- Mr. Thomas presented, pursuant to Statute-
  - Public Service Act—Postmaster-General's Department—Recommendations in cases of promotions of—
    - V. E. Butler, as Assistant Manager, 3rd Class, Electrical Engineer's Branch (Telephones), New South Wales.
    - M. J. Clavin, as Inspector, 3rd Class, Inspection Branch, Queensland.
- Mr. O'Malley presented, pursuant to Statute-
- Public Service Act-Sixth Report on the Commonwealth Public Service by the Commissioner.
- 5. LAND TAX ASSESSMENT BILL.—The Order of the Day having been read for the resumption of the debate on the question—That the Bill be now read a second time—and on the amendment moved thereto by Mr. Deakin, viz.:—That the following words be inserted in the motion after the word "That":—"the form of land tax outlined by the Prime Minister, and provided for in this Bill, is unjust in its incidence and an abuse of Federal powers"—
  - Debate resumed.
  - Mr. Sinclair addressing the House, and not having concluded his speech, the House ordered that he have leave to continue his speech when the debate is resumed.
  - Ordered—That the debate be now adjourned, and that the resumption of the debate be made an Order of the Day for to-morrow.
