TUESDAY, 25TH OCTOBER, 1910.

- 1. The House met, at three o'clock p.m., pursuant to adjournment.-Mr. Speaker took the Chair, and read Prayers.
- 2. MESSAGES FROM THE GOVERNOR-GENERAL.—ASSENT TO SUPPLY BILL (No. 3) 1910-11 AND TRUST FUND ADVANCES BILL (No. 2).—The following Messages from His Excellency the Governor-General were presented, and the same were read by Mr. Speaker :—

At end of clause add—

"Provided that the Commonwealth may impose such taxes land and other as may be necessary for the peace order and good government of the Territory."

Debate ensued.

Mr. Sinclair moved the following amendment :---

At end of clause add---

"Provided that the Commonwealth may in the interests of persons holding estates within the Territory grant concessions if considered advisable."

Debate ensued.

Amendment negatived.

Mr. W. Elliot Johnson moved the following amendment :---

At end of clause add-

"Provided that no limitation shall be imposed on the right of the Parliament to alter the conditions of tenure from time to time as may be deemed expedient in the interests of the Commonwealth."

Debate ensued.

Amendment negatived.

Clause agreed to.

Clause 11 read.

On the motion of Mr. Batchelor the following amendment was made, after debate :---

Lines 41 and 42, omit "shall, by virtue of this Act," and insert "may".

Clause, as amended, agreed to.

Clause 12 read.

On the motion of Mr. Batchelor the following amendment was.made :---

Line 1, omit "by" and insert "under".

Clause, as amended, agreed to.

Clause 13 agreed to.

Clause 14 read.

Mr. Finlayson moved, That the clause be taken in sub-clauses.

Debate ensued.

Question—put and negatived.

Mr. Finlayson moved the following amendment :---

Page 5, sub-clause (b), omit all the words of the sub-clause after the word "constructed" in line 1, with the view of inserting in place thereof the words "such railway lines within the Territory as may be necessary for the development and settlement of the Territory."

Debate ensued.

Question—That the words proposed to be omitted stand part of the clause—put. The Committee divided—

Mr. McWilliams moved that the following new clause be added to the Bill :----

10A. The amount of compensation to be paid by the Commonwealth for any land to be acquired or for any leases resumed by the Commonwealth within the Northern Territory shall not exceed the unimproved value of the land or lease on the first day of July, One thousand nine hundred and ten, together with the value of the improvements thereon.

Debate ensued.

Question—That the clause proposed to be added, be so added—put and negatived. Schedule agreed to.
