4. JUDICIARY BILL (1910).—Mr. Hughes moved, pursuant to notice, That he have leave to bring in a Bill for an Act to amend the Judiciary Act 1903-1907.

Question—put and passed.

Mr. Hughes then brought up the Bill accordingly, and moved, That it be now read a first time.

Question—put and passed.—Bill read a first time.

Ordered—That the second reading be made an Order of the Day for Tuesday next.

5. Referendum (Constitution Alteration) Bill (1910).—Mr. O'Malley moved, pursuant to notice, That he have leave to bring in a Bill for an Act to amend the Referendum (Constitution Alteration) Act 1906-1909.

Question-put and passed.

Mr. O'Malley then brought up the Bill accordingly, and moved, that it be now read a first time.

Question—put and passed.—Bill read a first time.

Ordered-That the second reading be made an Order of the Day for Tuesday next.

6. Australian Industries Preservation Bill (1910).—The Order of the Day having been read for the second reading—Mr. Hughes moved, That the Bill be now read a second time.

Debate ensued.

Question—put and passed.—Bill read a second time.

Mr. Speaker left the Chair, and the House resolved itself into a Committee of the Whole

(In the Committee.)

'Clause 1 agreed to.

Clause 2 read.

On the motion of Mr. Hughes, the following amendment was made, after debate:-

After line 21, at the end of clause add new paragraph:-

- "(e) by adding at the end of the section the following sub-section:—
 - '(3.) It shall be a defence to a proceeding for an offence under paragraph (a) of sub-section (1.) of this section, and an answer to an allegation that a contract was made or entered into in restraint of, or with intent to restrain, trade or commerce, if the party alleged to have contravened this section proves—
 - (a) that the matter or thing alleged to have been done in restraint of, or with intent to restrain, trade or commerce, was not to the detriment of the public, and
 - (b) that the restraint of trade or commerce effected or intended was not unreasonable."

Clause, as amended, agreed to. Clause 3 agreed to.

Clause 4 debated and agreed to.

Clauses 5, 6, and 7 agreed to.

Title agreed to.

Bill to be reported with an amendment.

The House resumed; Mr. Poynton reported accordingly.

Mr. Hughes moved, pursuant to contingent notice, That the Standing Orders be suspended to enable the remaining stages to be passed without delay.

Question—put and passed.

On the motion of Mr. Hughes, the House adopted the Report, and the Bill was read a third time.

No. 1.—Page 2, clause 6, paragraph (b), first column, line "Printed Papers"—after "Printed -PAPERS" insert "AS PRESCRIBED".

No. 2.—Page 2, clause 6, paragraph (b), first column, line "Books Published and Printed Outside Australia"—leave out "Published and".

No. 3.—Page 2, clause 6, paragraph (b), second column—Rates of Postage on item "Books Published and Printed Outside Australia"—leave out figure "2" (twice occurring) and insert figure "4" in each case.

No. 4.—Page 2, clause 6, paragraph (b), first column, line "Books Published and Printed in Australia"—leave out "Published and".

No. 5.—Page 2, clause 6, paragraph (b), first column, line "Commercial Papers, Patterns,

Samples, and Merchandise"—after "Merchandise" insert "as Prescribed".

On the motion of Mr. Hughes, the House agreed to the amendments, after debate.

SCHEDULE OF THE AMENDMENTS MADE BY THE SENATE.

No. 1.—Page 2, after clause 9 insert the following new clause and heading:—

" Acquisition of Land.

"9A. Section ten of the Seat of Government Acceptance Act 1909 is amended Application of by omitting the proviso thereto, and inserting in its stead the following Lands proviso:—

1906. proviso:-

'Provided that, in determining the compensation to which the owner is entitled under that Act, the value of the land shall be taken not to exceed the unimproved value of the land, or the interest therein of the owner, on the eighth day of October, One thousand nine hundred and eight, together with the value of his interest in the improvements on the land at the date of the acquisition of the land."

No. 2.—Page 3, clause 11, line 8, leave out "therefore", insert "thereupon".

On the motion of Mr. O'Malley, the House agreed to the amendments.

9. Post and Telegraph Bill (1910).—The Order of the Day having been read for the second reading -Mr. Tudor moved, That the Bill be now read a second time.

Debate ensued. Question—put and passed.—Bill read a second time.

Mr. Speaker left the Chair, and the House resolved itself into a Committee of the Whole.

Clauses 1 to 4 agreed to.

Title agreed to.

Bill to be reported without amendment.
