- 1. The House met, at half-past two o'clock p.m., pursuant to adjournment.-Mr. Speaker took the Chair, and read Prayers.

3. BANKING COMPANIES RESERVE LIABILITIES BILL.—The Order of the Day having been read for the further consideration of this Bill in Committee of the whole House-Mr. Speaker left the Chair, and the House resolved itself into a Committee of the Whole.

Debate resumed on the amendment moved by Mr. Greene, viz.:-

Line 1, omit all the words after the word "means" with a view to the insertion of the following words in place thereof "profits which may be lawfully distributed as dividends".

Progress to be reported, and leave asked to sit again.

4. Pearl-shelling Industry-Royal Commission.—The Order of the Day having been read for the resumption of the debate on the following motion of Mr. Bamford: That a Royal Commission, selected from Members of this Parliament, be appointed to take into consideration all matters pertaining to the employment of white and coloured labour now, and to be, employed in the Australian pearl-shelling industry, and in respect of the general conditions under which such industry is now conducted--

Debate resumed.

Mr. Mahon addressing the House, and not having concluded his speech, the House ordered that he have leave to continue his speech when the debate is resumed.

Ordered-That the debate be now adjourned, and that the resumption of the debate be made an Order of the Day for Thursday next.

- 5. MILITARY FORCES-PAY AND ALLOWANCES-SELECT COMMITTEE.-The Order of the Day having been read for the resumption of the debate on the following motion of Mr. Ryrie:-
 - (1) That a Select Committee (with power to send for persons and papers) be appointed to inquire into the pay and allowances of the warrant, non-commissioned officers, and men of the Permanent Military Forces of the Commonwealth.

And on the Amendment moved thereto by Mr. Kelly, viz.:—That the word "commissioned," be inserted before the word "warrant" in the second line of paragraph (1) of the motion— Debate resumed by Mr. Cann (in continuation).

The time allowed for precedence of General Business having terminated, Government Business was called on.

Mr. Frazer moved, by leave, That the Orders of the Day, Government Business, be postponed until to-morrow, and that the motion of the Honorable Member for Gwydir (Mr. Webster) with reference to the Report of the Royal Commission on the Postal Services have precedence for the remainder of to-day's sitting.

Debate ensued.

Question—put and passed.

Mr. Webster resumed and concluded his speech on the question.

Mr. Frazer moved, That the debate be now adjourned.

Question—That the debate be now adjourned—put and passed.

Ordered—That the resumption of the debate be made an Order of the Day for to-morrow.
