3. 5. Commonwealth Bank Bill.—The Order of the Day having been read for the further consideration of this Bill in Committee of the whole House—Mr. Speaker left the Chair, and the House resolved itself into a Committee of the Whole.

Clauses 2 and 3 agreed to.

Clause 4 debated.

Mr. Fisher moved an amendment, That the word "Bank" be inserted after the word "the" (first occurring) in line 4.

Debate continued.

Question—That the word proposed to be inserted be so inserted—put and negatived.

Clause agreed to.

Clause 5 debated and agreed to.

Clause 6 agreed to.

Clause 7 debated and agreed to.

Clause 8 agreed to.

Clause 9 debated and agreed to.

Clause 10 debated.

Mr. Fisher moved an amendment, That the following words be added at the end of the clause:—
"together with interest at the rate of three and a half per centum per annum."

Debate continued.

Amendment agreed to.

Clause, as amended, agreed to.

Clause 11 debated.

Progress to be reported, and leave asked to sit again.

The House resumed; Mr. Poynton reported accordingly.
Resolved—That the House will, to-morrow, again resolve itself into the said Committee
