OF THE

HOUSE OF REPRESENTATIVES.

FRIDAY, 15TH DECEMBER, 1911.

- 1. The House met, at half-past ten o'clock a.m., pursuant to adjournment.—Mr. Speaker took the Chair, and read Prayers.
- 2. Loan Bill.—The Order of the Day having been read for the consideration in Committee of the whole House of His Excellency the Governor-General's Message No. 25—
 Mr. Speaker left the Chair, and the House resolved itself into a Committee of the Whole.

(In the Committee.)

Mr. Fisher moved, That it is expedient that an appropriation of moneys be made for the purposes of a Bill for an Act to authorize the raising and expending of the sum of Two million four hundred and sixty thousand four hundred and seventy-six pounds for construction of a Railway from Kalgoorlie to Port Augusta, for the acquisition of land in the Federal Capital Territory, for the purchase of land and erection of buildings in London, for the redemption of loans raised by the Government of South Australia in connexion with the Northern Territory which are redeemable by the Commonwealth, and to pay to the State of South Australia amount expended from Revenue towards construction of Railway from Port Augusta to Oodnadatta.

Mr. Bamford moved an amendment, That the words "for the acquisition of land in the Federal Capital Territory," be omitted from the motion.

Debate continued.

Question—That the words proposed to be omitted stand part of the question—put and passed.

Original motion agreed to.

Resolution to be reported.

The House resumed; Mr. Poynton reported accordingly.

Mr. O'Malley moved, pursuant to contingent notice given by Mr. Fisher, That the Standing Orders be suspended to enable the remaining stages to be passed without delay.

Question—put and passed.

The Resolution reported from the Committee was, on the motion of Mr. Fisher, adopted by the House.

Ordered—That Mr. O'Malley and Mr. Hughes do prepare and bring in a Bill to carry out the foregoing Resolution.

Mr. O'Malley then brought up the Bill accordingly, and moved, That it be now read a first time.

Question put and passed.—Bill read a first time.

Mr. O'Malley moved, That the Bill be now read a second time.

Debate ensued.

Question—put and passed.—Bill read a second time.

Mr. Speaker left the Chair, and the House resolved itself into a Committee of the Whole. F.8496.
