Mr. Frazer presented, pursuant to Statute-

- Public Service Act—Postmaster-General's Department—Appointment of H. M. Cox as Assistant Engineer, Electrical Engineer's Branch, Western Australia.
- 4. Time of Meeting on Wednesdays and Thursdays.—Mr. Fisher moved, pursuant to notice, That on Wednesdays and Thursdays in each week the House shall, unless otherwise ordered, meet at half-past ten o'clock a.m.

Clause 11—

Mr. Tudor moved an amendment, After line 19 insert new sub-clause:-

"(2.) Every British ship (other than those registered in Australia or engaged in the coasting trade), when going to sea from any place in Australia shall be provided with a duly certificated Master and such duly certificated officers as are, by the law of that part of the British Dominions in which the ship is registered, prescribed as being necessary for her when going to sea from any place in that part of the British Dominions."

Debate ensued.

Clause postponed.

Clause 12 debated and agreed to.

Clauses 13 and 14 agreed to.

Clause 15 debated and agreed to.

Clause 16 agreed to.

Clause 17 debated-

Sir Robert Best moved an amendment, That the word "charge" wherever occurring in the clause be omitted and the word "question" be inserted in place thereof.

Debate continued.

Amendment negatived.

Clause agreed to.

Clauses 18 to 21 agreed to.

Clause 22 debated and agreed to.

Clauses 23 and 24 agreed to.

Clause 25 read.

Progress to be reported, and leave asked to sit again.

The House resumed; Mr. Poynton reported accordingly. Resolved—That the House will, to-morrow, again resolve itself into the said Committee.

7. Adjournment.—Mr. Hughes moved, That the House do now adjourn.

Question—put and passed.
